3 acknowledge the Committee Counsel Lance Polivy, and
4 the today the Committee on State and Federal
5 Legislation will consider three home rule
6 Resolutions: SLR008-2021 would allow certain
7 carpenter members of the city's pension system to
8 stop paying additional member contributions for
9 benefits they cannot receive based on their age and
10 years of service. SLR 009-2021 would provide that
11 going forward, promotions to serve in a supervisory
12 position in New York City Department of Sanitation
13 would be subject to competitive examination and
14 SLR0010-2021 would provide automotive members of New
15 York City Employees Retirement System who began their
16 careers later in life with the ability to receive a
17 vested retirement benefit. Do any Council Member
18 have questions about these SLRs? Do we have anybody
19 who wishes to speak? All right, seeing none, I call
20 upon the clerk to take a roll call vote.

21 LEGISLATIVE CLERK: Good afternoon,
22 William Martin, Committee Clerk, roll call vote,
23 Committee on State and Federal Legislation, three
24 preconsidered SLRs which are coupled. Chair Maisel.
