6 want to... we still love you. Wow. Girl Be Heard rolls
7 very deep I see, very deeply. There we go. Again,
8 welcome everybody, everybody's a bit giddy which is
9 great and exciting here in City Hall. Today the New
10 York City Council is deeply proud to honor Jessica
11 Greer Morris.

13 MAJORITY LEADER CUMBO: ...for
14 demonstrating outstanding leadership for over ten
15 years as the Executive Director of Girl Be Heard.
16 Girl Be Heard is an incredible organization that she
17 co-founded to develop, amplify and celebrate the
18 voices of young women in New York City through
19 socially conscious theatre making and for any of you
20 that have been here at City Hall Girl Be Heard has
21 utilized their voice to champion so many issues here
22 at City Hall. We would not be able to pass so much
23 incredible legislation without the dynamic voices of
24 the young women that are here today because they have
25 utilized all of their talents in order to make sure

2 that the issues that matter most to New York City are
3 amplified at the highest level. I am proud to
4 represent the bright lights of Broadway in my Council
5 district to see the theatre as something that is so
6 quintessentially New York City being used to elevate
7 the voices of young women is absolutely inspiring.
8 Jessica Greer Morris's personal accomplishments are
9 too numerous to name here, she was named by Newsweek
10 as one of the 150 fearless women who shake up the
11 world..

16 rights advocate, playwright performer and producer,
17 her work has been performed off Broadway at the White
18 House, at the U.S. Mission to the United States, at
19 the TED Women conference and at the New York Fringe
20 Festival. Talk about accomplished but I think even
21 more important than her own accomplishments is what
22 she has done on behalf of and in service to others.
23 This is especially true with regard to her work as
24 co-founder and Executive Director of Girl Be Heard.
25 Originally called the project girl performance

2 collective and rebranded as Girl Be Heard in 2013,
3 this exemplary organization has been putting on
4 workshops and performances for over a decade now.
5 These programs and workshops create a safe,
6 supportive environment for young women to learn and
7 grow and have their voices heard, something we can
8 all agree is sorely needed in today's world. Miss
9 Greer Morris has truly distinguished herself and her
10 service to others, New York City is so fortunate to
11 have her and I'd like to call her up to receive this
12 proclamation because she is a true New Yorker and
13 exemplifies the very best of this city and what I
14 love about her the most is that she when she comes to
15 City Hall she always allows the young women in the
16 program to speak for the organization and that's the
17 greatest accomplishment is when those that are
18 participating in your program can speak volumes
19 louder than the Executive Director or the Board of
20 Trustees or any of the other higher ups could ever
21 do. The young women that have come through this
22 program have gone on to do remarkable things and will
23 continue to change the world. So, without further
24 ado, we are going to call Jessica up to receive this

3 by the Clerk who is right behind me.

4 COMMITTEE CLERK: Council City of New
5 York Proclamation. The New York City Council is proud
6 to honor Jessica Greer Morris for more than ten years
7 of outstanding leadership as the Executive Director
8 of Girl Be Heard, an organization she co-founded to
9 develop, amplify and celebrate the voices of young
10 women through socially conscious theatre making and
11 whereas Miss Greer Morris is a human rights advocate,
12 playwright, performer and producer who's theatrical
13 work has been performed off Broadway, at the White
14 House, the U.S. Mission to the United Nations, the
15 TED Women Conference, and the New York Fringe
16 Festival. Newsweek named her as one of the 150
17 fearless women who shake up the world. For more than
18 a decade she has been shaking up the status quo by
19 utilizing her skills as, as a storyteller to champion
20 social justice to inspire fellow activists and to
21 encourage younger generations of women to become
22 change makers themselves and whereas in 2009 Miss
23 Greer Morris was invited by Ashley Marinaccio to get
24 involved with an ensemble at the EstroGenius
25 festival. After they co-produced a show about teen

2 girls in Niger Miss Greer Morris gave up other
3 theatre commitments to become the Executive Director
4 of the project girl performance collective, a group
5 that began taking on social issues impacting women
6 and girls abroad. She teamed up with 100 youth
7 advocates from 25 countries through the man up
8 campaign which she helped launch at the 2010 world
9 cup in South Africa in a shared commitment to ending
10 violence against women in their communities. From the
11 start she recognized the power of storytelling and
12 theatre to inspire and mobilize, to instruct and
13 educate and to harness the collective energy that
14 gets results and whereas to expand their workshops
15 and performances beyond the EstroGenius festival,
16 Miss Greer Morris and Miss Marinaccio chose to create
17 a not for profit organization with Miss Greer Morris
18 serving as the founding Executive Director, Miss
19 Marinaccio is the founding Artistic Director and
20 Jackie Shapiro as it's founding Board Chair, they
21 found rehearsal space and opened doors at the United
22 Nations. Nonprofit status was obtained in 2011 but
23 due to the recession and limited bandwidth the co-
24 founders did not go on payroll until 2013, the year
25 the organization was rebranded as Girl Be Heard. And

whereas Girl Be Heard's programs and workshops create a safe, supportive environment for young women to discuss the issues they care about and to learn how to work together as an ensemble. The curriculum fosters healthy confidence, self, self-aware women who are engaged in their schools and communities. And whereas a few of the organization's award winning productions have included America's Dirty Secret, which exposed the hardships of navigating the welfare system, food pantries and foster care in the wake of the 2009 recession; trafficked which focused on the experiences of survivors of sex trafficking; displaced which dealt with the refugee crisis and embodied which, which illuminates girl's struggles with body image. Other titles include Child Bride and Nine Millimeter America. And whereas in 2003 Dena Adrians, the organization's founding Director of Education introduced Girl Be Heard's program into a formal curriculum which is now taught by 22 teaching artists in 12 title one schools, two community-based settings and detention centers in New York City and abroad. The theatre company has toured Bermuda, Bosnia and Herzegovina, Denmark, England, Switzerland, Taiwan and Trinidad and Tobago. In 2016,

And whereas Miss Greer Morris has truly distinguished herself in her work and is worthy of the esteem of all New Yorkers. Now therefore be it known that the New York City Council gratefully honors Jessica Greer Morris for her outstanding service and enduring contributions to our community; Corey Johnson, Speaker for the entire council, Laurie Ann Cumbo, Majority Leader, Carlina Rivera, Co-Chair of Women Caucus, Margaret S. 22 born at NYU hospital in 1968 and my father-in-law
23 pulled me out of my mother's womb and then I
24 delivered my twins at NYU in 2003 so I do want to
25 recognize my beloved husband and son Charlie who are

9 womb a grassroots activist, a proud member of ACT UP,
10 a planned parenthood advocate, a supporter of so many
11 life changing movements from Black Lives Matter to Me
12 Too and I had the honor of using these skills as
13 Karen Koslowitz knows when I worked for the City of
14 New York from 1991 to 2005, I got to address the age
15 crisis in homelessness as the District Manager of
16 community board four, I got to open up syringe
17 exchange programs when I was at the New York City
18 Health Department, I got to do alternative sentencing
19 and get New Yorkers drug treatment and access to
20 social services instead of incarcerating our very own
21 citizens and I did that with Mr. Morgenthau who
22 passed on Sunday who was a mentor to me and I got to
23 work as a first responder during the World Trade
24 Center disaster and find the remains of, of loved
25 ones whether it was a tooth or a bone so that people

3 their loved ones. My social, social justice work is
4 in my blood and I have no doubt learned more from my
5 failures than any successes and I want to say this as
6 we stand on stolen ground blocks away from the

8 understand that it is our country's failures that can
9 and should be our greatest teachers. This is why we
10 do street performances like Say Her Name which we do
11 on the steps of City Hall and at sacred burial
12 grounds like the one down the street from us. We are
13 still hurting from our history and must speak out
14 against all forms of misogyny, racism and oppression.
15 If we don't listen to the whispers of loving parents
16 like Eric Garner's mother, we will hear the screams
17 and protests of artists and activists working to move
18 the needle on social justice issues. I could not be
19 prouder of my Council Members who are wearing this
20 incredible shirt, Karen can you show them what you're
21 wearing, I can't breathe, we are working together on
22 these social justice issues and this is why girls and
23 gender non-conforming youth must be heard, this is
24 why we develop, amplify and celebrate the voices of
25 the next generation of leaders to take the stage and

3 are also humble enough to know that we stand on the
4 shoulders of giants here at City Council who have
5 advocated for our movement time and again. While it
6 is deeply disturbing that only 12 of the 51 Council

8 to go, today is the day to celebrate those 12 women
9 who have broken countless glass ceilings to get where
10 they are and where we are today, we love you and we
11 need more of you, you make me proud to be American.
12 During a time like this I have shame about the
13 flagrant racism, sexism, xenophobia and transphobia
14 trickling down from D.C. but nothing makes me prouder
15 than this City Council led by my dear friend Corey, I
16 don't know where you are Corey but thank you for
17 everything you've done for me professionally and
18 personally and courageous leaders like Laurie,
19 Vanessa, Farrah, Carlina, Helen, Carlos, Ritchie,
20 Steve and Brad, too many to name who have supported
21 our after school and weekend programs throughout the
22 city. We have been there for each other on weekends
23 and nights when life gets hard, since social justice
24 work is a calling we must be there to answer when the

17 the 200 names of New York's bravest who have
18 succumbed and lost their lives because of 9/11
19 related illnesses and I hope the United States Senate
20 votes on this bill today to permanently reauthorize
21 and this is not a partisan issue this is about doing
22 what is right for these families and for the
23 survivors who are still battling 9/11 related
24 illnesses and I want any member of the United States
25 Senate who would attempt to speak out against this

2 bill to meet with these families of these 200 men and
3 women to look them in the eyes and to tell them why
4 the United States government should not permanently
5 take care of the heroes who served in the aftermath
6 of the largest attack that has ever taken place on

8 Senate must vote today to finally take care of these
9 families, the House did it, the Senate must do it, we
10 must not retraumatize these survivors or make them
11 anxious by having them wonder will the U.S.
12 government step up to support them. So, I hope that
13 this is not a partisan issue, I hope that we just do
14 the right thing. In addition to these brave
15 firefighters I'm also sad to share that we've learned
16 of the deaths of nine other 9/11 first responders
17 since our last meeting three weeks ago, nine more
18 people have died, one of the heroes... they're all
19 heroes, one of the main heroes who has dedicated.. he
20 dedicated his life, NYPD Detective Luis Alvarez, 53
21 years old testified many times on Capital Hill, he
22 fought for the rights of 9/11 first responders
23 tirelessly, he passed away a few weeks ago at the end
24 of June from cancer contracted down at Ground Zero,
25 NYPD Detective Luis Alvarez, age 53. NYPD Detective

2 Andrea Rainer who was a retired member of the 109th
3 precinct, 58 years old; retired Sergeant Jack Casey,
4 he served almost 40 years and had been honored with
5 two medals of valor for his acts of bravery,

7 old; Michael Ornauer, a Captain of the Long Beach
8 Fire Department who supported with field
9 communications at Ground Zero, he was 60 years old;
10 Simon Koch was a Detective with the F... with the NYPD,
11 I don't have his age; Christopher Cranston, 48 years
12 old, he was an NYPD Detective who spent six months,
13 six months working down on the pile; Nicholas
14 Polisenio, he reported to work down at Ground Zero
15 while working with Con Edison, he was 41 years old;
16 retired Sergeant Thomas Fennessy, age 64, he served
17 in the NYPD for more than 20 years and Detective
18 Thomas Santoro served down at Ground Zero with the
19 NYPD. These people deserve our support and their
20 families deserve our support, do the right thing
21 permanently authorize the 9/11 victim compensation
22 fund and do it today. I also want to recognize a
23 number of others who we lost who have passed in the
24 weeks since our last stated meeting first
25 construction worker Rene Traverio was killed earlier

3 Bronx. We have lost another member of the FDNY to
4 suicide, the fourth in the last month, officer Kevin
5 Preiss was 53 when he took his own life, my thoughts

8 get the help that they need if they are struggling.
9 Our law enforcement officers take an oath to serve,
10 we need to make clear that they're... we are there for
11 them in their time of need so that women and men in
12 uniform do not hesitate to ask for help, New York
13 City will support you. We've also recently lost two
14 incredible leaders and advocates for our city; Hector
15 Figueroa was a visionary labor leader who dedicated
16 his entire life to helping working women and men
17 across this country and especially here in New York
18 City, he led the charge for better wages, for better
19 working conditions, he did not care if you were a
20 member of his union or not, the fight for 15... if you
21 were a working person in our city who needed help
22 Hector was in your corner. A year ago when we were
23 passing a bill to help taxi workers in New York City
24 those workers were not part of 32 BJ, Hector was here
25 supporting them, name any issue that benefited

8 our city through some of its most tumultuous time, he
9 helped transform the Manhattan DA's office into the

11 country and he worked tirelessly as a civic leader

13 Athletic League, the Museum of Jewish Heritage and in
14 recognition Armenian genocide, I am deeply
15 appreciative of the work that both of these men did
16 for the greatest city in the world, our city, New
17 York City and lastly there's one that's personal to
18 us, Celena Glenn who worked at the New York City
19 Council for 31 years served under five Speakers, she
20 began her tenure as Council Member Enoch Williams's
21 Chief of Staff and eventually transferred over to the
22 central staff, her contributions were endless and as
23 many of you know she embodied integrity and inspired
24 it in those around her, we are grateful for her 31
25 years of service, we'll miss her tremendously. I know

6 thank the staff who worked on this Chris Sartori and

8 sponsored by Council Member Grodenchik would amend
9 reporting requirements for organizations that are
10 affiliated with elected officials but that do not
11 engage in promotional activities such as advertising
12 for those elected officials. Based on feedback to a
13 local law passed last session and with the support of
14 the conflicts of interest board this bill sets
15 separate reporting requirements for these
16 unrestricted organizations without changing the
17 requirements for restricted organizations. This bill
18 will still require unrestricted organizations to
19 report to COIB but to do so without placing an undue
20 burden on them and in a manner that will allow COIB
21 to focus its oversight on the types of concerning
22 activities that both COIB and the law we passed
23 intended for them to focus on. I want to thank the
24 staff who worked on this Brad Reid, Michelle Lee and
25 Chris Sartori. Next, Introduction 886-A sponsored by

2 Council Member Rafael Espinal will require a pilot
3 program for pet harbors that will allow owners to
4 leave pets unattended in safe enclosed shelters on
5 sidewalks adjacent to commercial establishments for a
6 short period of time, congratulations Rafael I know
7 you've worked hard on this and I want to thank the
8 staff who worked on this James Giovanni and Elliot
9 Lynn and I want to thank James and Elliot for a bunch
10 of the bills we have coming up. From transportation
11 we have Introduction 1457-A sponsored by Council
12 Member Carlos Menchaca. This bill will allow cyclists
13 to follow pedestrian control signals at leading
14 pedestrian interval intersections providing them with
15 a head start to enter the intersection before the
16 lights turn green for automobile drivers. We also
17 have two bills related to parking, Introduction 84-A
18 by Council Member Chaim Deutsch, will help clarify
19 whether certain parking restrictions are in effect by
20 requiring the Departments of Education and
21 Transportation to post information online about when
22 public schools are in session over the summer and
23 Introduction 570-A sponsored by Council Member Mark
24 Treyger, would create a defense to parking violations
25 in cases where both sides of the parking sign are

2 ineligible... illegible. I want to thank James and
3 Elliot for those... package of bills as well. Lastly,
4 we will vote on a package of bills designed to help
5 small businesses by providing them with needed
6 information and training and by collecting data
7 related to the city's storefronts that will inform
8 policy going forward. The city currently lacks the
9 data necessary to make informed decisions relating to
10 the small... to small businesses that are so vital to
11 our communities and these bills will tackle that
12 issue head on. Introduction 1049 sponsored by Council
13 Member Rivera would require an assessment of
14 storefront businesses and the business environment of
15 20 community districts every three years including a
16 survey of the business owners in coordination with
17 community-based organizations. From Council Member
18 Mark Gjonaj the Chair of our Small Business
19 Committee, Introduction 1467-A will require the
20 Department of Small Business Services to create an
21 online portal containing user friendly listings of
22 rules and regulations applied to small businesses,
23 this portal will be updated as agencies make rule
24 changes, an easy way for small businesses to know
25 what the rules are and to streamline it and Council

2 Member Gjonaj, Chair Gjonaj also has Introduction
3 1000-B and it will establish the city definition for
4 microbusinesses which are those with fewer than ten
5 employees and it would require specific reporting by
6 small business services on these mom and pop type

8 City. I want to congratulate the Chair on these two
9 bills. Introduction 1471-B sponsored by Council
10 Member Rosenthal would provide additional support to
11 the small business community by requiring small
12 business services to provide training and education
13 relating to efficiency, regulatory compliance and
14 marketing and also from Council Member Rosenthal
15 Introduction 1472 will require reporting on
16 commercial properties and would establish a public
17 data set of information related to leases, vacancy
18 and property specifications. Collecting this
19 information and making it accessible now is key to
20 sound policy making in the future and I want to thank
21 Rachel Cordero and Irene Borowski for their work on
22 this package of bills. The Council is going to vote
23 on three important resolutions. Intro... Resolution 746
24 put forward by Council Member Carlina Rivera calls on
25 the New York State legislature to pass legislation

3 hospitals related to drug testing people who are
4 pregnant or giving birth and I want to thank Emily
5 Balcon on the staff for working on this Resolution.
6 Resolution 740 from Council Member Brad Lander calls

8 Services to implement a policy that the mere
9 possession or use of marijuana does not itself create
10 an imminent risk of harm to a child or warrant a
11 child's removal and I want to thank Paul Sinegal from
12 the staff for working on that resolution and finally,
13 finally and so vitally important Resolution 897-A
14 from Council Member Daneek Miller, the Chair of our
15 Committee on Civil Service and Labor, this is co-
16 sponsored with Council Member Margaret Chin which
17 calls on congress to pass and the President to sign
18 legislation permanently authorizing the 9/11 victims
19 compensation fund as I already mentioned and this
20 resolution we are standing up and telling Washington
21 that these first responders, police officers,
22 firefighters, sanitation workers and other victims of
23 the horrific attack that we experience are better
24 than to keep having to go back to ask for support. I
25 want to thank Kevin Kotowski for working on this

6 Corey Johnson, we will now move into discussion of
7 general orders. For those of you who have bills that
8 are being voted on today specifically we will now
9 begin with Council Member Carlos Menchaca.

10 COUNCIL MEMBER MENCHACA: Thank you so
11 much Majority Leader and I rise to speak on 1447...
12 1457-A. The city has been working incredibly hard
13 around Vision Zero and made a lot of investments yet
14 today we stand with some incredible misfortunes. We
15 have seen deaths this year for cyclists higher than
16 in recent years and we still fundamentally treat
17 bicycles like cars and other motor vehicles. In fact,
18 the national safety administration has now for the
19 second year reported and we now note that motor
20 vehicle accident... or motor vehicle crashes fell
21 nationwide by one percent, but cyclist fatalities
22 nationally has soared ten percent while pedestrian
23 deaths rose four percent. Just today we released...
24 received news that in Staten Island another death has
25 happened for cyclists, that makes 16 cyclists dead

this year, ten last year, this is wrong, and it needs to stop. The culprit in, in this transportation conversation is the culture that continues to privilege cars and treat cyclists like drivers or motor vehicles rather than what they are more, more like which are pedestrians. We blame cyclists, we blame pedestrians, this has to stop. The Speaker is calling on an incredible vision for data driven comprehensive redesign so that we bring dignity and safety back into our communities. I first introduced this bill in 2016, that took us a long time to get the DOT and the NYPD to work together and we did that, we had patience and we sat down, this is not something that we just created a couple of months ago. That led to a study that the NYPD and the DOT conducted that led to really great information and I want to share with you if you are on the fence, the results say that over the seven months conducted between April and October of 2018 they documented a decrease in 27 percent drop in injuries at intersections and what we know is that intersections are where people die. I ask you to support this bill 1457-A. Thank you.

5 COUNCIL MEMBER GJONAJ: Thank you Madame
6 Chair. Locally owned mom and pop shops are in trouble
7 and far too many are finding it harder and harder to
8 keep their doors open whether it be to big box store
9 competition, consumer behavior changes, the internet,
10 rent, real estate taxes or government regulation our
11 small businesses are finding it more and more
12 difficult to keep their doors open. Businesses with
13 less than ten employees are responsible for almost 80
14 percent of New York City's workforce. So, it is not
15 an exaggeration to say that our city's local economy
16 and success is dependent on having a thriving small
17 business sector. Today this body is considering a
18 package of bills and, and in particular two that I
19 have introduced that will bring much needed relief to
20 struggling local businesses. The first step in
21 solving any problem is to define it, we need to be
22 more proactive than reactive, the hurdles faced by
23 local dry cleaner and butcher can be very different
24 from those faced by general electric and Amazon. The
25 federal government defines small businesses an entity

2 of up to 1,500 employees and the state defines it at
3 up to 100 employees. We need a stronger focus on much
4 smaller businesses that is why I've... I'm the proud
5 sponsor of Intro 1000, a bill that establishes the
6 term micro business as one with less than ten
7 employees. This bill will also require SBS to survey
8 these businesses to help assess the actual issue they
9 face. Once we have the data, we can take proactive
10 and targeted programs to address these specific
11 needs. New York City has approximately 6,000 rules
12 and regulations that govern businesses, many are
13 outdated and are a mystery even to government workers
14 that are responsible for enforcing them. It is almost
15 impossible for business owners who are juggling
16 payroll, suppliers, and changing customer trends to
17 have the time to keep up with the maze of municipal
18 regulations that govern their businesses. I'm also
19 proud to sponsor Intro 1467, this bill would require
20 SBS to establish a searchable interactive guide to
21 aid business owners in understanding the city rules
22 and regulations. I want to thank the Council staffers
23 who have helped make these bills a reality, a special
24 thanks to the bill drafters and government affairs
25 division including Robin Newman, Laura Pulpal, Rachel

10 COUNCIL MEMBER CHIN: Thank you Majority
11 Leader. I want to speak about the life of Staff
12 Sergeant James McNaughton and the street co-naming in
13 his honor that we are voting on today. I want to
14 begin by acknowledging his parents who are here
15 today, William and Michelle and the officers that are
16 here today Chief Delatorre, inspector Mundo, Captain
17 Fudacaro, Sergeant Brennan, Detective Rudolph and
18 police officer Kenny. Jimmy embodied the very best of
19 NYPD, selflessness, duty and honor. In addition to
20 serving in transit district two, Jimmy was an army
21 reservist. In the weeks after 9/11 he patrolled the
22 subways to reassure his fellow New Yorkers during a
23 time of extreme fear and anxiety. When the Iraq war
24 began Jimmy was redeployed and joined his fellow
25 officer at Camp Victory in Bagdad to train Iraqi

police officers. Upon hearing reports of snipers in the area, Jimmy volunteered for guard duty despite the danger. In an act of selflessness Jimmy argued that he was the better candidate for the job given that he was single while other officers had family back home. While guarding the camp in 2005 a sniper bullet ended his life, he was only 27 years old. He became the first NYPD officer killed in Iraq and his legacy lives on in the memory held by his family, friends and his fellow NYPD officers. He was honored with a bronze plaque in transit district two headquarters. In a touching personal tribute the locker Jimmy used is permanently sealed. Our New York City Council must do it's part to ensure that Jimmy's legacy is never forgotten, I believe we can do this by approving the proposed application to co-name West Broadway between Lespinot and Canal Street James McNaughton Way, this is one small thing that our city can do to express our gratitude for his sacrifice and service to our city and our country and I urge all my colleagues to support it, thank you.

I just want to call attention to the life of reverend James, Jimmy Miller, he was born August 17th, 1932, he grew up in Harlem but moved to east New York and we were able to have the benefit of his service to our community. He grew up in a close-knit family and they were centered on providing service in the community, I guess that led to the roots of his being so involved in so many community organizations. He enlisted in the U.S. Army and served in the Korean war, he was married to his wife Ethel for 63 years and after 26 years of service to the New York City Triborough raging tunnel Associations he retired. He was ordained as a minister in 1960 and he served as an assistant pastor of the First Baptist Church... First Faith Baptist Church and co-pastor of the Second Emanuel Baptist Church. He was installed as a pastor in 1995. Among the many community and civic organizations that he was involved with, he was a pas worship master of the masonic temple, he was Chair of the representative counsel for a better New York, he was Chair of the school board for the east New York Alliance, President of the Louis H. Pink House Tenant

4 in all the work that he has done and also in his son,
5 our colleague, I. Daneek Miller so it gives me great

12 Majority Leader, Leader. Today we are voting on Intro
13 84, my bill that will clarify parking regulations
14 around school facilities during the summer sessions.
15 Intro 84 will, will require that prior to June 30th
16 every year the Department of Education post a list of
17 all locations with summer sessions that are active in
18 New York City public schools and then report these
19 locations to the Department of Transportation. DOT is
20 then required to list the corresponding.. the, the
21 corresponding locations where there is restricted
22 parking that is in effect on summer school days. By
23 making this list public.. publicly available we are
24 ensuring that the city is transparent about
25 regulations surrounding schools. We're also taking

2 steps to ensure that unwarranted parking violations
3 are not issued to unsuspecting drivers. Intro 84 is a
4 way to properly inform New Yorkers about already
5 existing parking spaces that are available during the
6 summer months where people would otherwise be afraid
7 to park because of a lack of accessible information
8 about summer sessions in a particular building, non-
9 existent parking can be a tremendous stress
10 particularly in areas with lack of accessible mass
11 transit. I encourage my colleagues to support this
12 bill and I thank my 12 colleagues who have signed
13 onto this bill for their co-sponsorship, I also thank
14 transportation committee Chair Ydanis Rodriguez and,
15 and James DiGiovanni Counsel of Transportation's
16 Committee for their work on this bill, thank you very
17 much.

21 another area for my district after Jean Baptiste
22 Point du Sable. Jean Baptiste Point du Sable is from
23 Haiti. He was the... he, he is known as the funder of
24 Chicago, he was the first person to settle in
25 Chicago, he created infrastructures and he was also

2 the one who was leading so many businesses in Chicago
3 if today we can talk about Chicago it is also because
4 of Jean Baptiste Point du Sable. If you go to Chicago
5 you will see a museum, school also libraries and

7 and I think that we are doing a wonderful job by
8 paying tribute to those two wonderful people who have
9 contributed as immigrants to the fabric and to the...
10 fabric and the goodness of the United States of
11 America, thank you very much Madame Majority Leader,
12 thank you.

14 too also have a few co-namings in my district that I
15 briefly just wanted to recognize as many of the
16 individuals are here. One, the Malbone Centennial Way

20 1918. It has been just over 100 years since this
21 terrible tragedy but in many ways, those lost souls

24 group effort throughout my community, Walt Whitman
25 was an American poet, journalist and essayist who was

7 in the borough of Brooklyn as well as we will be
8 doing a change in the reading of sign for Christopher
9 notorious BIG Wallace Way on Saint James Place
10 between Fulton Street and Gates Avenue in Brooklyn.
11 Christopher Wallace was a cultural giant whose name
12 has become synonymous with style, attitude, action
13 and artistic freedom, a son of Brooklyn, he is
14 perhaps one of the most influential figures to ever
15 come out of the borough and is internationally
16 recognized throughout the world. I also want to
17 recognize, and the family of Randy Weston are here
18 today, Randy Weston is an artistic jazz giant, an
19 international legend who is known throughout the
20 world. He is a composer, a pianist, and has traveled
21 throughout the world utilizing so many different
22 sounds from West Africa, Moroccan and later Egyptian
23 and East Asian elements all throughout his sound. He
24 is a Brooklyn native, a giant for 70 years enchanted
25 music lovers of all ages were welcome to his studios

2 across the country. I personally had an opportunity
3 to work with Randy Weston as he performed in many of
4 our NYCHA developments in outdoor concerts for free,
5 he gave up his life and he gave us his talent freely

8 daughters, his wife and partner are certainly an
9 example of the extraordinary bond between two people
10 and finally I want to recognize a very tragic story
11 in my district, Melquain at the intersection of Gold
12 Street and York Street he was tragically killed
13 waiting at a bus stop outside of the Farragut Houses.
14 His family later started a scholarship and emergency
15 fund in the name at John Jay College where he earned
16 his bachelor's degree. This co-naming honors the son
17 of Brooklyn who overcame all odds to be the best that
18 he could be, this co-naming represents Mal Quan's
19 fight for excellence and education in our black and
20 brown communities. He was only 17 years old and he is
21 joined today with his mom who has fought tremendously

22 900 children each summer. Mr. Morris really was a, a
23 local and a national hero and his, his story about
24 his World War II exploits were documented in a book
25 that his daughter wrote, Delores Morris wrote in 2015

When a parking sign is illegible people don't have notice that a restriction is in effect but can still receive a ticket. It is within the Finance Department's discretion to dismiss these tickets, but they're not required to do so, and many people don't know that they might be able to get their ticket dismissed for, for illegible signs and the standards for dismissal can be unclear. There should also be more pressure on DOT to maintain parking signs. This speaks to greater problems within DOT, it takes too long for studies to be completed, for traffic lights to be installed and other traffic measures to be in place and just maintain your signs. So, I want to thank the Speaker, his staff, my office and everyone who helped make this bill possible and I ask my colleagues to vote aye and with that I vote aye on all.

9 right, we've had so many lawsuits, Laticia James has
10 filed so many lawsuits right now it's about making
11 sure that our children will be serviced by a special
12 education system to get educated and the families get

15 this promise to service those families, I'm asking
16 for the state and the governor to sign a resolution

3 require HPD to provide temporary housing for tenants
4 in their community district or immediately adjacent
5 community district. Our city needs to take all
6 measures necessary to minimize disruptions to tenants

8 break the cycle that forces too many tenants into
9 shelter systems, and I urge all my colleagues to join
10 me on this bill, thank you.

11 MAJORITY LEADER CUMBO: Thank you Council
12 Member Chin and I also want to acknowledge my interns
13 that are here; Pavitra Rosharon, Alisha Omed, Hope
14 Brown and Iyana Henry, it's so dynamic to have you
15 all here today, I see you all waving, I'm just so
16 happy to have all of this new talent in my office and
17 I also wanted to acknowledge my predecessor, the
18 late, great James E. Davis who was certainly a
19 political giant and inspired many, many other elected
20 officials to run for office, he was a true champion,

22 fighter and stood up very strongly around issues
23 around gun violence and it's so tragic that his life
24 would be taken away right here in the Council
25 chambers so I always view and see the Council
