22	I am proud to have sponsored this bill
23	along with 27 of my Colleagues. The Committee
24	previously heard testimony on the bill on February
25	29, 2024. In 2022, the New York State Legislature

2	passed legislation mandating DOE limit the number of
3	students in class across all of its K-12 schools
4	through a five-year phase-in process beginning in the
5	fall of 2023. Though New York City Public Schools
6	currently provides a report on the average class size
7	of all DOE schools and programs, reporting on actual
8	size would provide increased transparency that will
9	allow the public to assess New York City Public
10	School's progress towards compliance with the law.
11	I would like to thank my Staff and
12	Committee Staff.
