2 CHAIRPERSON RECCHIA: Okay. Good
3 morning and welcome to today's Finance Committee
4 Hearing. My name is Domenic M. Recchia, Jr., and
5 I'm the Chair of this wonderful Committee.
6 Today's the first Finance Committee Hearing since
7 we adopted the Fiscal 2012 Budget on June 29th,
8 and I am pleased to be reunited with my Committee
9 Members. Today we have four items on our agenda:
10 we have a transparency resolution, a budget
11 modification, and two Land Use items. First,
12 let's start with the Land Use item, the first is a
13 Preconsidered Resolution that would provide a tax
14 exemption for a property located at 823 Colgate
15 Avenue in The Bronx. This property which consists
16 of four buildings, that has 972 units, has a new
17 owner who has agreed to provide affordable rental
18 housing to low income families in return for
19 getting a tax exemption. Shhhh. This property is
20 in Council Member Maria Carmen del Arroyo
21 district, and she supports this project. The next
22 Land Use item is located at 1201 Finlay Avenue in
23 The Bronx. The property seeks property tax
24 exemption for rehab of three buildings. The
25 property in Council Member Helen Foster's

2 district, and she supports this. And our next
3 item relates to the adopted Fiscal 2012 Expense
4 Budget, which we adopted on 20--On June 29th.
5 Generally, this transparency resolution makes
6 mostly technical corrections to the designations
7 that were listed in Schedule C. The Resolution
8 also makes changes to designations made in Fiscal
9 2011 and 2010. For clarification purposes, it is
10 to be noted that organizations appearing in the
11 resolutions that have not yet completed the
12 prequalification process by the Mayor's Office of
13 Contracts, by the Council or other government
14 agencies are identified with an asterisk next to
15 its name. Additionally, as with all transparency
16 Reso, Council Members will have signed to a
17 disclosure indicating whether or not a conflict
18 exists with any group. If a Council Member has a
19 potential conflict with any of the organizations
20 listed, they may want to disclose the conflict at
21 the time and before they vote. Representatives
22 from the Council Finance are available to answer
23 any questions you may have regarding the Land Use
24 items and the transparency resolution. Our last
25 item is an expense mod for Fiscal 2011. This mod

2 is necessary to implement many provisions that
3 were reflected in previous transparency
4 resolutions and today's transparency resolution.
5 This modification transfers about \$700,000 between
6 agencies to fund Council's local initiatives,
7 local initiatives, and the net effect of the
8 modification is zero. Before we take a vote, I'd
9 like to introduce all my colleagues who joined us
10 here today. We've been joined by Jimmy Oddo,
11 Vincent Ignizio, Robert Jackson, Leroy Comrie,
12 Julissa Ferreras, Karen Koslowitz, Lewis Fidler,
13 Diana Reyna, Joel Rivera, Fernando Cabrera, and
14 Darlene Mealy. Okay? Does anybody have any
15 questions? Without seeing any questions, please
16 call the roll.
