COMMITTEE: Sanitation and Solid Waste Management

**TITLE:** A local law to amend the administrative code of the city of New York, in relation to commercial recycling.

**SPONSORS:** Council Members Eugene and The Speaker (Council Member Quinn) and Council Members Brewer, Comrie, Crowley, Dickens, Dromm, Ferreras, Fidler. Gonzalez. Koppell, James. Koslowitz, Lander, Lappin, Mark-Viverito, Palma, Recchia, Rodriguez, Seabrook, Vann, Williams, Rose, Nelson, Gennaro, Van Bramer, Levin, White and Chin

Summary of Legislation: Proposed Int. No. 141-A would require the Department of Sanitation to complete a study on commercial recycling by January 1, 2012. The study would integrate date on commercial waste that is collected and transferred in the City and assess current waste and recycling practices, providing for the first time an accurate picture of the state of commercial waste management in New York City. The study would further analyze waste production and disposal by sector and would result in a series of recommendations for changes to local laws. Routes for the collection, transfer, and disposal of waste would be mapped and monitored in order to assess their efficiency for possible improvements in the longer term.

**EFFECTIVE DATE:** This local law shall take effect immediately.
