2	CHAIRPERSON REYNA: Good morning.
3	My name is Diana Reyna, Chair of the Committee on
4	Small Business. Today, the committee will vote on
5	Proposed Intro 256-A, which aims to further
6	improve the reporting requirements for development
7	projects administered by the Economic Development
8	Corporation.
9	On November 4th, this committee
10	held its first hearing on this bill, where
11	advocates strongly testified in favor of passing
12	this bill. Proposed Intro 256-A will create
13	increased transparency for Economic Development
14	projects and improve public accessibility by
15	making a few simple changes.
16	First, it would expand the duration
17	of the reporting period for all projects,
18	regardless of the project's starting date, from
19	the current seven years to however long the
20	project is in existence and still receiving
21	subsidies from the city.
22	Secondly, it would create a list of
23	sales and leases of city-owned property to be
24	added to the report that would also include the
25	rent cost and selling price of each lease and

2	sale.
3	Lastly, it would mandate that the
4	reports be placed in a nonproprietary database
5	format on EDC's website, therefore increasing
6	transparency for the public's use.
7	These changes would allow more
8	information regarding the success or failure of
9	Economic Development projects to be in the public
10	sphere, and allow the public to analyze the
11	reports with greater ease and effectiveness.
12	I'd like to thank Kris Satori, our
13	counsel to this committee; Matthew Hickey, our co-
14	counsel as well; and Ralph Hernandez, our finance
15	analyst.
16	We have been joined by committee
17	members Letitia James, Peter Koo and Margaret
18	Chin.
19	Lastly, I just want to thank EDC
20	for their cooperation on the expansion of the
21	transparency goals that we have embarked on with
22	the Council.
23	Without further ado, I'd like to
24	call a vote on this legislation. I recommend and
25	urge my committee members to do so as well, in
