Broadway Family here that I'm going to be

on Broadway. And Broadway, Inside Broadway, an
important part of not only the arts community, but
also the economic and the business community here

12	SPEAKER QUINN: Thank you. If I
13	could ask my colleagues before I speak on the
14	legislation to rise for a moment of silence,
15	please. On August 7th, 2011, Hugh Leo Carey, the
16	51st Governor of our great state passed away at
17	the age of 92. He was born in Brooklyn in 1919;
18	Hugh Carey graduated from St. John's University
19	and St. John's Law School and was a highly
20	decorated World War II veteran. He served seven
21	terms in congress and was a member of the infamous
22	Four Horsemen, where he joined Ted Kennedy, Pat
23	Moynihan and Tip O'Neill advocating for a peaceful

solution to the conflicts in the North of Ireland.

Elected Governor in November 1974, he served two

terms and was the architect of the financial plan
that averted the bankruptcy of our own New York
City. He instituted the I love New York program,
founded the Empire State games, and early in his
term signed the Willowbrook Consent Decree, which
committed the state to sweeping reforms in the
care of developmentally disabled. Known as much
for his wit as for his powerful intellect,
Governor Carey was gifted with Irish charm and a
love of song. This past week, prior to his
funeral mass at the main altar, Governor Carey
laid in state in the Lady Chapel at St. Patrick's
Cathedral. This was the same chapel where he
married his late wife, Helen, in 1947. Together
they had 14 children. Governor Carey found great
joy in his children, his 25 grandchildren, and his
six great grandchildren. A grateful city and
state will always be indebted to the work and
legacy of governor Hugh Carey. Our thoughts and
prayers go out to the entire Carey family and
extended Carey family. Thank you.

We are voting on two important pieces of legislation today. The first, intro 632-A, a piece of legislation sponsored by Council

Member Mark Weprin, and shepherded through the 2 Civil Rights Committee by Chair Debbie Rose. 3 want to thank both of them. I want to thank 4 5 Jillian Beckford, Damien Butvick, Alix Pustilnik and Rob Newman for their work on this legislation. 6 631-A makes changes to the City's Human Rights Law, and it makes changes as it relate to religious observance. For too long workers in New York City in both the public and the private 10 11 sector have been forced to choose between a job 12 they love and need to support themselves and their 13 family and fully observing their religion. changes that 632-A will make will raise the 14 15 standard as it relates to protecting people's 16 right to full religious observance as it relates 17 to the workplace. This is an important piece of legislation making it very clear that we don't 18 19 want to ever put somebody in the position where 20 they have to choose between a job and their 21 religion. That is simply not what New York City 22 is about, simply not what America is about and I 23 want to thank everyone who has worked on this 24 piece of legislation. In particular I want to thank the Sikh Coalition. They were critical to 25

working with us on this bill, and they have been
terrific, particularly Amar Singh [phonetic],
partners in our ongoing effort to fight bullying
and discrimination in all its forms in New York
City, particularly our work on the respect for all
curriculum and our work in the New York City
public schools. Let me first call on the sponsor
of this bill, Mark Weprin, and thank him for this
piece of legislation, as well as his ongoing work
with the Sikh coalition and others against
religious discrimination in the workplace and in
other places, of course; and then call on the
chair of the Civil Rights Committee, Council
Member Rose. Council Member Weprin?

COUNCIL MEMBER WEPRIN: Thank you,
Madam Speaker. My colleagues, it's a happy day
for me and I'm really proud to be involved with
this legislation. I want to thank the speaker for
being so forceful in getting this through. This
really does raise the standard that an employer
will have to follow when they accommodate a
religious accommodation. Currently there is
confusion over what standard should apply. And
the federal standard, which the City has often

followed, is a much weaker standard than the one that we are putting in place here today. And, you know, as someone who represents Queens County, Queens County, as many of you know, is the most diverse county probably in the world. And in Queens, you know, diversity isn't just a bumper sticker, it's a way of life. And we're very proud of a lot of our new immigrants, immigrants who took a chance to come to this country for economic freedom, for religious freedom, as so many millions and millions of people have done before them. I think it's an important message for us to send as a Council that we will not tolerate employers who do not try to accommodate people's religious freedoms, and to accommodate their beliefs. And as the Speaker mentioned, someone should not0 have to choose between their religious practices and whether to take a job. And this law will make it much stricter when someone has a certain practice in their religion for that to be accommodated. And that's why I'm proud to sponsor this bill here today. It is a very good step forward. I to want to thank the Sikh Coalition for the work they have done. The Sikh population

in my district has been very adamant on this
issue. They have often felt that there is
discrimination based on those who might wear a
turban or have a beard, or who have other articles
of faith that they may have to carry through and
to live their life. And we want to let them know
that this is America, and in America we think
everyone should enjoy the full embrace of the
America's constitutional freedoms, and that is the
statement we are making here today, that we feel
very strongly in people's freedom of religion and
people's ability to serve this City. And if
someone who is a citizen, who is raising their
family and paying taxes here in this city wants to
put themselves out on the line and serve this city
and protect maybe my family, I think we should do
everything we can to accommodate them. So thank
you, Madam Speaker. Thank you Chair Rose for your
help with this legislation. And I thank my
colleagues and hope they'll vote in the
affirmative. Thank you.
SPEAKER QUINN: Thank you, Council
Member Weprin. Chair Rose?
COUNCIL MEMBER ROSE: Thank you,

Madam Chair, and thank you for your leadership on this bill. Today we're voting on a piece of legislation that will send a clear and poignant message to all employers in the City of New York, that religious discrimination in the workplace will become a thing of the past. No longer will an employer be able to deny an employee the right to openly practice the tenets of their respective religions, which unfortunately has become more of a common occurrence over the years.

Under the current City Human Rights
Law, an employer is required to provide a
reasonable accommodation for an employee's
religious observance, so long as it does not cause
an undue hardship for the employer. Since the
current law doesn't provide a definition of undue
hardship, Intro 631-A would amend the City's Human
Rights Law by defining undue hardship as a
significant expense or difficulty, which is more
comprehensive and stringent than the federal
definition of undue hardship, thereby ensuring
that workers are further protected from religious
discrimination in the workplace, and clarifies our
intentions to provide greater protection to

workers under the City Human Rights Law than the
federal human rights provisions now provide. I am
proud to have played a part in seeing this bill to
fruition, and I want to thank Council Member
Weprin for sponsoring this piece of landmark
legislation. I would also like to thank my
Committee staff Julene Beckford and Damien
Butvick. I'd like to thank my staff, Legislative
Director Antonio Whitaker, the Sikh Coalition, and
other advocates, for the outstanding work that
they have all done on this bill. I thank you
again, Speaker, and Mark Weprin for bringing this
forward. Thank you.

much, Chair Rose. The second piece of legislation we're voting on is Intro 541-A. I want to thank the sponsor of the bill, Council Member Wills, the Chair of the Consumer Affairs Committee, Dan Garodnick, who shepherded this bill through his Committee. I want to thank Rachel Cordero, Damien Butvick, Alix Pustilnik, and Lacey Clarke, who worked on this legislation. Intro 541-A does two important things. One, under the law now it is illegal for retail establishments to sell expired

over the counter medication, but there is no prohibition on individuals selling expired over the counter medication. And in fact, in Council Member Wills's district, he came across flea markets and garage sales where people were doing just that. Obviously those expiration dates are there for a reason; they're there for a reason because prior to that expiration date is the safest and most effective time to take that medication. 541-A will now make it illegal for any individual to sell expired over the counter medication, just as it is illegal for a retail establishment to do that.

Second, right now in New York City, the only entity that can enforce the prohibition of sale of expired over the counter medication is the New York State Attorney General. We will amend the City law and give enforcement powers in addition, both as it relates to retail establishments and individuals, to the New York Police Department, and to the Department of Consumer Affairs. So, again let me thank the Chair for his work on this, Dan Garodnick, and call on the bill's sponsor, Council Member Ruben

Wills.

COUNCIL MEMBER WILLS: Thank you
Madam Speaker. I first want to thank the Speaker
for her leadership on this bill and the Chair of
Consumer Affairs, Council Member Garodnick. This
legislation protects the health and safety of
consumers by keeping expired medications off the
shelves and away from those consumers. The
potency of the over the counter medications is not
guaranteed beyond its expiration date. This
becomes problematic for those who procure and use
expired over the counter medications, who may
unknowingly take inaccurate doses or take
medication that has become ineffective. Decreased
potency can have an adverse effect on those who
depend on these medications, such as a person with
heart disease who takes aspirin as a blood
thinner. I urge my colleagues to vote in favor of
legislation that will protect New Yorkers. It is
the responsibility of anyone who is selling over
the counter medications to put the health and
safety of consumers ahead of profits and sales.
Thank you.

approach April 26th, as many members as possible
will take this opportunity to inventory their food
pantries, assess what those needs are. People are
out there who want to provide food to the needy,

101st birthday of Mother Theresa by making the
sacrifice, by putting our food pantries in good
shape for the year ahead, knowing what we have

COUNCIL MEMBER WILLIAMS: you. I also want to congratulate my colleagues Weprin and Wills on their bills. I wanted to speak on two bills. The first one, Intro 656 by Melissa Mark-Viverito, Danny Dromm, and especially the Speaker for her leadership on this. from an immigrant family. I represent probably 80% or more immigrant communities. I have family that are undocumented. They aren't aliens; they are human beings who are undocumented and they have provided wonderful things to this city and this country, and the policies should be changed so that family isn't torn apart. I was happy that our government did the right thing, and I'm very upset that our President has done the opposite on this particular issue, and hope that we can show the way when it comes to this.

Second, on Resolution 986, Melissa Mark-Viverito and Oliver Koppell, this is very close to me as well. I've got a lot of young people in my district that have been dealing with this issue. And for me, I reserved my worst and harshest words until now. This is basically just

a racist policy. Because I was hoping that after
getting all the information the Mayor might do
something about it, but clearly he is not. And
the silence to me now has been worse than the
policy. There are over 80% of the people who are
stopped, young men of more color, when statistics
show that it is young white people who use
marijuana on a moreon a larger basis. And if
there was 80% of white anything being abused in
this fashion, there would be some changes. So
it's very disheartening to me that this has not
even been addressed. And as I said before, I
would like the Major to let us know if our young
people are second-class citizens, so that we can
move accordingly. If they are not, things like
this need to be addressed in a much quicker
fashion. Thank you.

9	Calamia to the HHC Board. Vincent Calamia is not
10	only a friend of mine, but an individual of
11	integrity. He has a reputation of being an adept
12	administrator. He's a stalwart advocate for
13	people on Staten Island who are in need and are
14	not getting adequate services. As you know, HHC
15	does not have a facility on Staten Island, and we
16	have a large need. And so Dr. Calamia has often
17	been in the middle of that fight to ensure that we
18	get the resources that we so deserve on Staten
19	Island from HHC. And I just want to congratulate
20	Dr. Calamia on his appointment to the HHC Board.

attention to my colleagues to a bill and resolutions that's being introduced. I'm sure you'd be interested in joining. The bill is a Local Law that really would require the Department of Homeless Services to report on a monthly basis the location of all their facilities. It's a transparency bill. I think we all can see the value of that. The resolution calling for the state legislature and governor to enact legislation to require the foreclosing party in mortgage foreclosure action to produce the pooling in service agreement. In other words, prohibiting people who don't own property to sell somebody else's property, essentially. And Reso 989, calling upon the state legislature and Governor to prohibit lenders from concealing mortgage assignments through the use of MERS--Mortgage Electronic Registration System. And finally, Reso 990, calling upon the Federal Reserve Bank to rescind its proposed rule requiring borrowers to pay off the remaining principal on a mortgage before the lender is forced to cancel the security interest in the home. Obviously it's onerous to have to try and pay that off before that
