This letter serves as our agreement with the Chair, Council Member Mark Weprin, and the encompassing members of the Subcommittee on Zoning and Franchises that we will commit to the following:

- We will remove the 2 tables and 4 chairs on either side of the overhead fire escape, in accordance with New York City Fire Department Regulations. A 3 foot sidewalk clearance 360 degrees around the fire escape will be maintained at all times.
- 2. One table and two chairs will be added to the west of the Greenwich Avenue restaurant entrance. The size of the café will remain at 7 tables and 14 tables.
- 3. The single table and 2 chairs on West 12 Street will be moved against the façade. The waiter service aisle will be located on the outside of that table, and the appropriate clearances to the fire hydrant will be maintained.
- 4. We will remove the six planters currently located on the corner of Greenwich Avenue and West 12 Street, as they have not been indicated on plans approved by the New York City Department of Consumer Affairs.
- 5. We will remove the sandwich board currently located within the sidewalk café zone.
- We will remove the bench currently located within the sidewalk café zone, as it has not been indicated on plans approved by the New York City Department of Consumer Affairs.
