4	name is Mark Weprin. I'm the Chair of the
5	Zoning and Franchises Subcomittee. We have
6	items that we heard yesterday in the committee
7	meeting. We had a hearing that we closed on the
8	Seaside Park and Community Arts Center that is
9	Land Use 994, 995, 96, 97, 98, and 999. The
10	following members of the Committee are here
11	with us today, Council Member Robert Jackson,
12	Council Member Al Vann, Council Member Dan
13	Garodnick, Council Member Jessica Lappin,
14	Council Member Vincent Ignizio and myself.
15	Others are on their way. We are going to move
