3 CHAIRPERSON RICHARDS: Alrighty this
4 hearing now begins. Good morning, or afternoon. I
5 am Council Member Donovan Richards, Chair of the
6 Environmental Protection Committee. And today the
7 committee will hear and vote on Intro 271A, the
8 first major revision of the air code since 1970.
9 Air pollution in New York City is a major health
10 problem contributing to approximately six percent
11 of all debts. Pollutants of concern include fine
12 particulate matter, Nitrogen Oxides, elemental
13 carbon and sulfur dioxide. New York City's air
14 quality intermittently and routinely violates the
15 EPA's national ambient air quality standards for
16 criteria pollutants and the city is designated a
17 nonattainment area for ozone pursuant to the clean
18 air act. While New York City is designated an
19 attainment, is designated in attainment for
20 particulate matter the clean air act also requires
21 EPA to periodically review the standards to ensure
22 that they provide adequate health and environmental
23 protection and to update those standards as
24 necessary. The EPA has proposed revisions of both
25 the ozone and particulate matter standards to make

2 them more health protective. According to the New
3 York City community air survey ozone and asthma
4 hospitalizations among children under 18 have
5 gotten worse in communities, districts that I
6 represent and other environmental justice
7 communities. We might, might not be an attainment
8 of new revised standards so we will still have, we
9 still have a lot more work to do. Other pollutants
10 such as nitrous oxide, sulfur dioxides, and nickel
11 remain at unsafe concentrations in our air. These
12 pollutants are conclusively linked with a variety
13 of health problems. Fine particulate matter is
14 small enough to become embedded deep within the
15 lungs and short term exposure can exasperate heart
16 and respiratory problems such as asthma. Long term
17 exposure to fine particulate matter has been linked
18 to reduced lung function, chronic bronchitis,
19 cardiovascular disease, and premature death. Sulfur
20 dioxide which converts in the atmosphere to sulfate
21 particles can cause difficulty in breathing,
22 increased respiratory systems and aggravation of
23 existing heart disease. Sulfur dioxide also
24 contributes to lower visibility and acid deposition
25 which has been of great concern in New York state

1 because it aids in formation of acid rains which in
2 turn damages plant and animal life, buildings, and
3 electrical equipment. In 1970 New York City passed
4 the air pollution control code to help alleviate
5 the impacts of these and other pollutants from the
6 multifarious sources from which they are admitted.
7 Although parts of the code have been amended over
8 time and parts have been added the entire code has
9 not received a thorough revision since the original
10 passage more than 40 years ago. Intro umber 271A
11 makes such a revision. Since we introduced the
12 revised air code last year many changes have been
13 made to improve the original document thanks to
14 advocates in industry and all these good people
15 who've been a part of this process. The changes
16 include an advisory committee which will be added
17 to advice DEP on future rule promulgations relating
18 to emission control technologies. Other changes are
19 certain engines are for, forbidden from being used
20 on construction sites without first being
21 registered with DEP and also passing smoke tests.
22 Notices of petition for variances will be published
23 by DEP on the internet going forward. Certain
24 trucks used by the Department of Transportation and

2 air vacuums are exempted from having to obtain work
3 permits before they are altered or installed. DEP's
4 process for suspending, revoking, and renewing
5 asbestos handling certificates is, is clarified.

6 Asbestos removal work that is stop by DEP due to a
7 condition that is immediately curable may resume
8 work as soon as the condition is corrected.

9 Abatement orders that are issued verbally by DEP
10 due to airborne particulate matter issues on
11 construction sites will be lifted immediately upon
12 DEP's determination that the condition has been

13 corrected. So the big word is regulation with a
14 capital R. Definitions of existing fire place and
15 new fireplaces, new and existing char broilers and
16 new and existing cook stoves have been amended. A
17 fireplace will be deemed an existing fireplace if
18 the application for its construction has been filed
19 before this law is affected. So that was a big on.

20 Fireplaces and wood burning heaters may be used as
21 a primary source of heat in emergency situations
22 only. The soonest dates on which DEP may promulgate
23 rules relating to certain existing char broilers
24 and new char broilers have been moved to a later
25 time. A method was added to calculate the amount of

2 meat cooked by a facility using a char broiler so
3 that there will be more reporting around that. The
4 effective date for a certificate of operation for
5 first time registration of stationary engines was
6 moved from one year after the law was enacted to
7 January 1st, 2018. Starting January 1st, 2025 the
8 certificates of operation for stationary generators
9 that must meet certain admission standards will
10 only be renewed if their owner or operator
11 demonstrates that they meet specified emission
12 standards except in cases of hard, undue hardship.
13 Small businesses we're helping there. An exemption
14 to the requirements for stationary engines was
15 added for emergency stationary reciprocating
16 internal combustion engines. Another change that
17 the city does not have to purchase zero partial
18 zero emission vehicles when DEP determines it would
19 be impractical to do so provided that the next
20 highest rating category available for such vehicles
21 is selected. And one of my favorite parts, a phase
22 out of schedule for school busses that do, do not
23 utilize a closed crank case ventilation system was
24 added phasing out such school busses by 2020. The
25 waiver of fees for mobile vending units equipped

2 with an auxiliary engine meeting tier 4 emission
3 standards is also limited to engines installed
4 within 18 months of the effective dates of the law.
5 The commissioner may also recommend no civil
6 penalty on a first violation of the sections on air
7 contaminate detectors and recorders and air
8 combustion shut off provided that respondents
9 admits, provided that the respondent admits
10 liability, files a certification that violation has
11 been corrected, and the commissioner accepts such
12 certification. Such violations may be used to
13 impose penalties for subsequent violations of the
14 same type. Based upon the changes that have been
15 made on this particular bill. I am voting in favor
16 of the bill as a, as revised and I do recommend a
17 yes vote by the committee. With that being said we
18 will call the vote.

16 did I say Reggie Thomas, Reggie Thomas oh Reggie
17 Thomas and I apologize to him in advance for all
18 those late night calls to talk of this bill and I
19 hope he accepts that even though he's not in this
20 room, and my staff Jerrell Burnie, Mercedes
21 Buchanan, and my colleagues who signed on very
22 early Costa Constantinides from Queens, Rory
23 Lancman, Eric Ulrich, and Steve Levin. Thank you.
