Declaring the City of New York a "TPP Free Zone"  
Proposed Res. No. 576-A (Res. 0576-2015)

Before the Committee on State and Federal Legislation  
New York City Council

April 27, 2015

Thank you Chairperson Koslowitz and members of the Committee for the opportunity to testify in support of this important resolution opposing the secret and damaging international trade deals that not only threaten our jobs, our environment and consumer safety, but undermine the right of City Council members and our representatives in Albany to take decisive action on behalf of their constituents.

Today's resolution sends a strong message to our congressional representatives, the entire Congress and the army of business lobbyists in the nation's capitol that the American public wholeheartedly rejects the corporate free-trade agenda, Fast Track and the secretive Trans-Pacific Partnership (or TPP).

Fast Track is a legislative process and an executive branch power-grab designed to accelerate the approval of TPP. It usurps the Congress' Constitutional authority over international trade agreements and prevents Congress from providing necessary oversight to negotiations over trade deals. The White House gets to choose the negotiating partners, finalize the trade deals and then submit the TPP to Congress for an up-or-down, take-it-or-leave-it vote. The American people deserve better.

Last week, New York Representatives Charlie Rangel and Joseph Crowley stood up for their constituents and voted against the Republican leadership's Fast Track legislation; Resolution No. 576-A will send a resounding message to the rest of our elected representatives that they should join Reps. Rangel and Crowley in opposing Fast Track.

I'm not here to say NO to the TPP and Fast Track. I'm here to say HELL NO to the TPP and Fast Track. New York City's working families don't need or want a repeat of the failed trade deal giveaways to companies that shift jobs overseas and use trade pacts to undermine commonsense environmental, public health and consumer protections.

These trade deals have been a raw deal for workers. New York City has lost more than 80,000 jobs just from the North American Free Trade Agreement and the China trade deals alone, according to the Economic Policy Institute. And there is widespread agreement among economists that these trade deals have significantly contributed to the growing income and wealth inequality that leaves so many New York City residents behind even when the overall economy prospers.

These trade deals not only destroy American jobs, they unravel and undermine important consumer protections and food safety rules that make trade literally a kitchen table issue. The TPP will bring a flood of imported food and fish that will swamp the ability of border inspectors to stop tainted or unsafe food.

For example, the TPP would open up U.S. supermarkets to a flood of imported fish from countries like Malaysia and Vietnam that often use veterinary drugs and fungicides that are banned in the United States to raise fish and seafood in overcrowded ponds. Since the volume of imported fish would increase but the number of inspectors at the border would not, uninspected shipments of potentially unsafe fish could end up in a grocery store near you.

The food and agribusiness industries even want to further weaken the already inadequate border oversight. These corporate interests have demanded a new TPP panel that can second-guess border inspectors that find potential problems. They also want inspectors to release potentially tainted foods into the food supply while awaiting test results, instead of releasing suspect food shipments only after they have cleared laboratory tests.

Trade deals like the TPP can also overturn or block commonsense food labels that inform consumers of the ingredients contained in their food and where products comes from. The U.S. country-of-origin labeling laws for beef and pork have been under attack by Canada and Mexico at an international trade tribunal since 2008.

Fast Track has specifically identified labels that identify genetically modified foods as illegal trade barriers that should be prohibited. Consumers have the right to know what they are eating. Citizens across the country, including here in New York State, are pushing for state laws to require the labeling of foods containing GMO ingredients, but the Republican Congress is undermining the ability of citizens and states to establish GMO labels.

The TPP will also amplify the pressure to increase fracking for natural gas, even in communities and states that have passed bans or moratoriums on the practice of fracking because it pollutes the environment and threatens human health. Citizens across the country have fought for years to protect their land, water and communities from the dangers of fracking. In 2014, New York became the first state to ban fracking, but more than 250 other communities have also enacted bans or moratoriums.

The TPP will make it harder to for communities to stand up to the gas and oil industry. First, the TPP would automatically approve natural gas exports to all the member countries — especially natural gas hungry Japan — without the normal public interest review and approval process that is required for all exports except for nations that are members of a U.S. free trade agreement. This will make it easier to export more natural gas and increase the pressure to drill more fracked wells, lay more pipelines and build liquid natural gas terminals. By exporting natural gas out of the United States, the domestic price will rise, making it more lucrative to invest in fracking.

The TPP could even challenge and ultimately overturn New York's fracking ban. The recently leaked TPP investment provisions would allow foreign oil and gas companies to challenge state and local efforts to ban fracking. These investment rules allow foreign companies to challenge federal, state and local laws and regulations that the companies claim "indirectly expropriate" their "reasonable investment-backed expectations."

This would allow corporations to sue (for financial damages) over rules that curb dangerous or abusive business practices (like pollution or financial fraud) or even require companies to provide sensible disclosure (like food labels). The oil and gas companies are already using a similar investment provision under NAFTA to prevent local governments from regulating fracking. A natural gas company has challenged a fracking moratorium in the Canadian province of Quebec, which was put in place to study the impact of fracking on the St. Lawrence River.

These kind of special investment rights for foreign companies put very commonsense local rules in jeopardy and have a chilling effect on municipalities like New York City that have strong public interest safeguards. That is why New York State Attorney General Eric Schneiderman wrote last week that these provisions are "particularly worrisome to those of us in states, such as New York, with robust laws that protect the public welfare — laws that could be undermined by the TPP and its dispute settlement provision."

The corporate free trade agenda is aiming directly at American workers, the environment and public health safeguards. I applaud the Committee for considering a resolution that will send a strong message to Congress, the White House and the corporate lobbyists that Fast Track and TPP are the wrong track for New York City. I urge the City Council to stand with New Yorkers and say HELL NO to Fast Track and the TPP.

CITY COUNCIL TESTIMONY – 4/27/15

My name is Edie Kantrowitz, I am with United for Action and New York City Friends of Clearwater, and I would like to thank the City Council for giving us the opportunity to speak today. I want to express my strongest support for the idea of establishing New York City as a “TPP Free Zone.” We must reject the Trans Pacific Partnership, as well as any and all trade agreements that violate our national sovereignty and allow giant corporations to overrule our national, state and local laws in the name of promoting “trade”.

I have no doubt that you will hear plenty today about how the TPP could threaten food safety, restrict internet freedom, send jobs overseas, and make it impossible for us to enforce our own environmental laws for which we have fought so hard. With droughts, earthquakes, warming temperatures and sea level rise already wreaking havoc and causing tragedy in the world today, I’m sure you’ll also hear plenty about how the TPP threatens any hope we may still have of containing climate change to manageable levels.

But I want to just focus right now on another matter, one that to me seems unspeakably callus. In the name of protecting profits for pharmaceutical companies, the TPP threatens to deny access to life-saving medications to those in developing countries where these medications are desperately needed. The humanitarian organization Doctors Without Borders explains that they rely extensively on generic medications in their programs to treat AIDS, malaria, tuberculosis and other infectious diseases. They state that “the first generation of HIV drugs have come down in price by 99 percent over the last decade, from U.S.\$10,000 per person per year in 2000 to roughly \$60 today, thanks to generic production in India, Brazil and Thailand, where these drugs were not patented. This dramatic price drop has been instrumental in helping scale up HIV/AIDS treatment for more than six million people in developing countries. About 80 percent of donor funded anti-AIDS drugs and 92 percent of drugs to treat children with AIDS across the developing world comes from generic manufacturers.”

The TPP not only has the potential to make it more difficult for new generic drugs to be manufactured and come on the market, but it could also allow for already existing generics to be removed from availability. This is accomplished by the technique of “evergreening,” in which pharmaceutical companies are permitted to obtain or extend monopoly protection for old drugs simply by making minor modifications to existing formulas, *even though these modifications may have no effect on the drug’s efficacy*. Of course, it’s difficult to know exactly what provisions the TPP will contain, since so much of it is so very secret. But even if it’s only new generics that would be restricted, how many millions of innocent children and adults would be condemned to death by the unavailability of needed medicines? What epidemics would we allow to flourish in the name of protecting pharmaceutical profits? How can those who promote the TPP have such a total and thoughtless disregard for human life?

This is just one more reason why we must reject the TPP – this trade agreement is not about trade, it is simply about putting corporate profit ahead of every other decent human value. Let’s declare New York City a TPP-free zone!

My name is Ling Tsou. We wish to thank Council Member Helen Rosenthal for introducing Res 576 declaring the City of New York a "TPP-Free Zone".

If TPP is passed and signed into law, this would threaten our existing policies to protect clean air, water and land of our country. We would not be able to stop fracking, the Keystone XL pipeline, defend the climate and build a green economy.

TPP is a trade agreement in name only. This is an agreement negotiated in secret with 11 Pacific Rim countries. In reality 600 of the world's largest corporations, including corporations like Chevron, Halliburton, Monsanto, Walmart and many others, are helping to compile a corporate wish list while the public and even almost all the members of Congress are kept in the dark. The little we know about TPP came from texts that have been leaked. Not a word of the draft text has been officially released. Leaked texts showed that Governments signing TPP must align their national laws and regulations with the terms of the agreement which sets rules on everything including food safety, internet freedom, drug affordability, financial regulations, labor rights and environment. For example, liquefied natural gas (LNG) exports can freely cross borders of TPP signatory nations and that environmental review of the public impacts is banned. Therefore, there would be no means of stopping LNG export terminals from sending fracked gas to Asia, where it commands prices six times higher than in the U.S. Effectively, TPP would foster a fracking shale gas boom in the U.S. As if this was not enough, the TPP also expands on NAFTA's "investor state" provisions, allowing corporations to sue nations for millions of dollars in private international tribunals over laws or regulations they claim affect their "expected future profits". For example, energy firm like Lone Pine Resources has used similar rules in NAFTA to sue Canada for \$250 million over Quebec's moratorium on fracking for oil and gas. In addition, TPP will outsource more jobs and bring hardship to many American working families.

If TPP is so good for the American people and our country, why keep it such a secret from the American public and Congress? Why not release the full text and let us have a debate on the merits of this agreement?

The only way we can stop Washington's mad rush to pass the "fast track" for TPP is for people to mobilize and speak out against TPP. I'm very glad that New York City council will join the growing number of cities across the country adopting resolution to oppose TPP.

My name is Ken Gale and I am the Founder of the New York City Safe Energy Coalition and the host and producer of the environmental radio show Eco-Logic on WBAI-FM here in New York City.

The Godfather movies had a line, "Nothing personal, just business." It was an illustration of Mafia immorality then, but now seems to be an accepted part of legal businesses.

NAFTA codified that attitude somewhat in the '90s and now the Trans-Pacific Partnership is looking to codify it to an extreme. Please pass this bill.

Government has a responsibility for the health and well-being of those who are governed. TPP would make that nearly impossible.

The Clean Water Act, Clean Air Act, and the Safe Drinking Water Act are pretty good pieces of legislation. People used to get sick from polluted air and polluted water. Some people died from that pollution. TPP, written by polluters, would find those laws a threat to "future profits" and attack them, not in public court, but a secret international tribunal. And when people get sick, they will no longer have access to generic drugs. TPP will get rid of those, too.

It's a local economic threat. Healthy workers and healthy students are more productive. Let's keep them that way. Pass this bill.

The Pacific Rim mining company already proved that corporations are willing to sue in order to *poison* people. The nation of El Salvador told them they couldn't put a gold mine in the mountains because it would put cyanide poisoning into the water supply of half the population. El Salvador was sued.

Another piece of good environmental legislation TPP would attack is the Endangered Species Act. Whether you feel those animals and plants were put on earth by God or Nature, we *do not* have a moral right to kill them. Don't allow Godfather morality to undo the Endangered Species Act. Please pass bill #576.

Still another piece of good environmental legislation TPP would attack is the City Council's own goal to reduce greenhouse gas emissions by 80%. Fossil fuel companies are writing TPP and would go after that, too.

Someone once told me that businesses are not IMmoral, they are A-moral, so long as they do what's legal. That is such a crock of, well, a word the FCC wouldn't allow me to say on the radio. Slavery was not amoral when it was legal, it was IMmoral. The chapters of TPP that would undermine hard-fought democratic freedoms are immoral, not amoral. Pass 576.

Good Morning, Members of the Committee.

My name is Audrey Iszard. I am an advocate for retirees and the Chair of the New York City Chapter of the Alliance for Retired Americans. I am speaking today on behalf of not just myself and all of the New York City members of the Alliance, but also the 4.3 million activists who belong to the Alliance nationally.

I've spent many years working to make sure that my fellow seniors and I will be able to retire with dignity.

Keeping our retirement secure means that we keep health care affordable for seniors. Unfortunately, the Trans-Pacific Partnership will not only deny working Americans fair wages and fail to live up to its promises, it will increase health care costs for retirees and people on Medicare. We don't know all there is to know about this deal - because most of it is secret at this point, but we do know that it reduces legal protections on prescription drug prices. It will make prices go up for all consumers and it will hurt the senior citizens who need these drugs the most. Prescription drug prices in the United States are already the highest in the world - and in 2014, they increased by 13 percent. 

## Testimony on New York City Council Resolution 576 April 27, 2015

Good morning, my name is Alex Gleason, and I am the Policy Associate at the New York City Central Labor Council, AFL-CIO. Representing 1.3 million workers, and 300 affiliated unions, the Central Labor Council is strongly opposed to the fast-track of the Trans-Pacific Partnership (TPP,) and in-favor of Resolution 576. Working people are being deprioritized for transnational, corporate interests. Perhaps one of the only issues with bipartisan support in Washington, the TPP will adversely affect the real income of 90% of citizens<sup>1</sup>. What are the details of the trade deal? Unfortunately, we do not know the specifics of the bill, as negotiations have occurred in the 'quiet rooms' and corridors of power in DC.

There are a number of details we *do know* about the TPP. We know the legislation will eliminate any sort of 'buy American' clauses for procurement, giving US firms no edge in the acquisition of goods and services by the government<sup>2</sup>. TPP will also create patent protections for much of the intellectual property of the world's largest corporations<sup>3</sup>; remove some of the rigorous health standards for food products sold in the United States<sup>4</sup>; and alter a number of regulations ensuring the safety of drugs that keep us healthy<sup>5</sup>. Additionally, the TPP will establish an international court to decide trade disputes with sovereignty over any individual state or institution<sup>6</sup>.

America has seen the result of poorly devised trade policy with the North American Free Trade Agreement (NAFTA.) for the last two decades, NAFTA has dramatically impeded the growth of the United States' domestic economy, and with it the middle-income jobs allowing workers to build wealth<sup>7</sup>. NAFTA has also created job and life displacement in the United States as well as Mexico. The flood of subsidized American agriculture into Mexico has effectively priced-out its own industry and workforce. Since enacting NAFTA, many Mexican farmers have been displaced from their livelihoods, and forced to migrate—sometimes dangerously—into the United States<sup>8</sup>. We can certainly expect worse from TPP.

Rather than empowering our states and municipal governments to facilitate economic growth, the TPP will give the largest, best-entrenched corporations a greater proportion of power and voice than currently enjoyed. The Trans-Pacific Partnership epitomizes a bad deal; it is bad for union members, non-union workers, small businesses, and the holistic well being of our city. Thank you for your time and consideration.

Dear New York City Council Members.

We, the small businesses in New York have been undermined by the unfair competition that allows big chain stores to brutally expand, while their products are made overseas with enslaved hands. Locally this trend is sponsored by policies that seek tax exemptions for developers and real state corporations while subject part of the needed investment on our communities to the creation of Business Improvement Districts that require new property taxes raising our rents.

At the National level, the deficit in manufacturing output, driven by free trade agreements, entails the lost of diversity of local economies. Any local business lost is also the lost of our ability to generate better products that meet local demands for consumers increasingly concerned about our environment and public health issues.

We all know how important is the international commerce to generate jobs, to keep prices under control or have access to good quality products. Competition is also important to keep our economic diversity where companies of all size can thrive. However, we also know that the so call FREE TRADE is a way to call the deepest regulation of the market in favor of very specific group of monopolistic interest.

Now is clear Free trade agreements are deleterious for our manufacturing output. The Clinton administration promised that NAFTA would generate 200,000 jobs between 1993 and 1995 and that during the second decade our trade balance would be 12 billion dollars annually in favor of US. Now we know that we lost more than 700,000 jobs mainly in our car industry and we have a negative commercial balance of 100 billion dollars with Mexico alone.

Our manufacturing trade deficit is even worse with China and our trade deficit is more than 300 billion.

In 2012 Obama Administration estimate that the trade agreement with Korea would increase our exports in 11 billion and would support 70,000 American jobs from exports alone, in reality we lost 40,000 jobs with Korea and our exports have fallen 3.5 billion. In 2011 our deficit with Korea was 13 billion, in 2014 the commercial deficit with Korea was 22 billion.

A true economic recovery, from the bottom, the one that reduce our income inequality, depends on small businesses competing on a more level playing field. Let's all remember: small businesses are more likely to develop emerging technologies than larger firms, with 16 times more patents per employee than the larger firms. Small business accounted for 60% of new jobs creation.

If TPP were approved, local policies for a true economic recovery, would receive lawsuits in international courts, if corporations considered that these might reduce their profits. The litigation against our communities would undermine citizens' initiatives as those that: seek to encourage the consumption of local products; defend the democratization of

credit; advocate for the protection of water sources from fracking; seek to raise wages; recall products that are harmful to the public health; seek to control the skyrocketing rents and limit the expansion of Business Improvement Districts in our neighborhoods.

Finally, we wonder: Without public debate, without public hearings with citizens and scientific experts and, even worse, without knowing exactly what they are voting for, where is the legitimacy of our Congress?

If this vote goes via fast track, our dream for a better democracy, the one that represents over 320 million American citizens, will die on the desk of those representatives of the 600 corporations who wrote the TPP.

A secretive group met behind closed doors in New York [last January for the TPP].... What they decided may lead to higher drug prices for you and hundreds of millions around the world.

Powerful companies appear to have been given influence over the proceedings, even as full access is withheld from many government officials from the partnership countries.

Trade agreements, and in particular individual provisions within them, are typically far more difficult to alter or repeal than domestic laws.... What's clear is that the overall thrust of the intellectual property section of the T.P.P. is for less competition and higher drug prices.

Of course, pharmaceutical companies claim they need to charge high prices to fund their research and development. This just isn't so. For one thing, drug companies spend more on marketing and advertising than on new ideas.

If big pharmaceutical companies hold sway — as the leaked documents indicate they do — the T.P.P. could block cheaper generic drugs from the market. Big PhRMA's profits would rise, at the expense of the health of patients and the budgets of consumers and governments.

The whole world may come to pay a price in the form of worse health and unnecessary deaths.

“The trans-pacific partnership will allow big pharmaceutical companies to maintain or increase their monopolies on brand name drugs and prevent generic drugs from entering the market. We cannot allow big pharma to increase its profits at the expense of patients' health and lives.”

**Statement from Josh Fox, prize-winning documentary film-maker and environmental activist:**

TPP proponents will tell you otherwise, but we know from leaked chapters that this deal will have disastrous consequences for the anti-fracking movement. Hidden provisions allow corporations to sue national, state, and local governments for passing environmental protections that interfere with their profits. Under a similar NAFTA rule, a company called Lone Pine sued the Canadian government for \$250 million for passing a fracking ban. The TPP will also make it harder for the US to manage its natural gas exports, encouraging more fracking to satisfy foreign markets like Japan. This deal could undo years of grassroots activism and threaten the health and safety of our communities.

**Testimony in Support of Resolution 576 Declaring NYC a “TPP-Free Zone” to the NYC  
Council Committee on Federal and State Legislation  
April 27, 2015**

**Pete Sikora

Hello, my name is Pete Sikora and I am the NYS Legislative/Political Director for CWA District One. We represent about 35,000 union members in a wide range of sectors living and working in New York City. CWA represents public sector, health care, telecommunications, manufacturing, media and other workers.

I will cover Fast Track and the Trans-Pacific Partnership’s (TPP) disastrous impact on jobs, wages, employment and income inequality. But I want to note that the treaty, if it’s Fast Tracked and approved, will also damage the safety of our food, increase air and water pollution, raise the price of vital prescription drugs, impede internet freedom, and eliminate consumer protections from Wall Street banks, among other serious effects.

Every so-called “free trade” deal is sold the same way by its proponents: it will create jobs through increased exports. Free traders, such as President Obama in this case, almost always talk about jobs “supported” by the deals. They ignore the impact of imports.

That’s how the Obama Administration sold the most recent big deal, KORUS. The Administration and the assorted corporate interests told us that the deal would “support 70,000 American jobs”<sup>1</sup> But in the first three years of the deal, **the U.S. goods trade deficit with Korea ballooned an estimated 84 percent, or \$12.7 billion** (comparing the year before the FTA took effect to the projected third full year of implementation). That corresponds to a net loss of 85,000 American jobs.<sup>2</sup> That’s the pattern of these bad deals: the deal is sold as a job creator for American jobs, then the deal is pushed through Congress, signed, and goes into effect - and the trade deficit promptly soars with that country or countries. While some export supported jobs are created, *net* jobs are lost.

Let’s look at the numbers: the aggregate U.S. goods trade deficit with Free Trade Agreement (FTA) partners is more than five times as high as before the deals went into effect, while the aggregate trade deficit with non-FTA countries has actually fallen. The aggregate U.S. trade deficit with FTA partners has increased by about \$144 billion, or 427 percent, since the FTAs were implemented. In contrast, the aggregate trade deficit

with all non-FTA countries has decreased by about \$95 billion, or 11 percent, since 2006 (the median entry date of existing FTAs). Growth of U.S. exports to FTA partners has been 20 percent lower than U.S. export growth to the rest of the world over the last decade (comparing annual average growth of 5.3 percent to non-FTA nations vs. 4.3 percent to FTA nations from 2004 to 2014).<sup>3</sup> Using the Obama administration's net exports – to – jobs ratio, the FTA trade deficit growth implies the loss of about 780,000 U.S. jobs. (NAFTA, by the way, is the worst culprit here)

Successive bad trade deals have greatly enhanced the ability of big investors and multinational corporations to move capital through investment flows and stronger contract rights – and therefore move jobs. These deals are greasing the skids of outsourcing and offshoring. Tens of thousands of CWA members have lost their jobs due to outsourcing and off-shoring. In New York State, just one company, Verizon, has moved over 1,000 call center jobs from New York to other countries. Those were good, middle-class union jobs, all moved overseas to cut costs. Economists estimate that approximately 20% of jobs currently can be off-shored. That includes everything from manufacturing to call center work and back-office functions to medical imaging. There is a huge range of good, middle-class jobs that can be outsourced.

The other side acts as if technological change is the only force making outsourcing easier. Don't believe it: these deals are critical to allowing corporations to move jobs to the lowest pay countries that have the weakest environmental, health, safety and labor protections. Job loss to off-shoring is not an inevitable consequence of technological advancement. It's a conscious set of policy choices that maximize corporate profits over the interests of American workers. (By the way, these deals also hurt workers overseas. NAFTA, for example, devastated small farmers in Mexico. All of those lost jobs and desperate people are a key driver of cross-border migration)

**The TPP is biggest deal yet.** It's a secret deal whose provisions are being negotiated behind closed doors, because they could never stand the light of day and pass as stand-alone legislation. We only know what's in the TPP because of leaks of the negotiating texts.

**The TPP would grant multinational and foreign corporations unprecedented rights over our laws at the Federal, State and Local level.** And it grants these rights to foreign corporations based in countries such as Vietnam, where the minimum wage is 52 cents an hour.

**For example, the TPP would prevent the City of New York from establishing local or domestic purchasing requirements for contracts. The City could no longer conduct preferential contracting to strengthen our local economy.** In fact, if the City did so, it would be subject to lawsuit in a private trade tribunal by a foreign corporation.

The corporation could sue to recover “expected future profits” lost and demand taxpayer compensation for these lost profits. The City of New York would have to pay to compensate a foreign corporation.

The leaked Investor State Dispute Settlement (ISDS) chapter is simply terrifying. It grants expansive rights to investors. Investment itself is defined in the leaked text as “every asset that an investor owns or controls, directly or indirectly, that has the characteristics of an investment, including such characteristics as the commitment of capital or other resources, the expectation of gain or profit, or the assumption of risk” (Article II.1). The text goes on to enumerate as examples regulatory permits; intellectual property rights; financial instruments such as stocks and derivatives; “construction, management, production, concession, revenue-sharing, and other similar contracts;” and “licenses, authorizations, permits, and similar rights conferred pursuant to domestic law.”

The chapter’s new rights and protections would extend to investments already existing before the TPP. It would permit compensation claims even over failed attempts to make an investment, with the low standard to qualify for attempting to invest being “concrete action or actions to make an investment, such as channeling resources or capital in order to set up a business, or applying for permits or licenses.” The expansive definitions would allow attacks on a vast array of non-discriminatory domestic policies and government actions from health and land use policies to construction permits and financial regulation.<sup>4</sup>

The leaked text shows that foreign investors would be able to demand compensation if new policies that apply to domestic and foreign firms alike undermine their “expectations” of how they should be treated. This includes a right to claim damages for government actions (such as new environmental, health or financial policies) that reduce the value of a foreign firm’s investment (Article II.7 and Annex II – B on indirect expropriation) or that go against the expected level of regulatory scrutiny that an investor might have had when dealing with a previous government (Article II.6 on minimum standard of treatment).<sup>5</sup>

These provisions would be a bonanza for multinational corporations. The deal would restrain the City of New York – and other levels of government – from law-making that might inhibit “expected future profits”. That’s why it is hard to imagine that the City would be willing to run afoul of the treaty and pass or continue to enforce local contracting requirements or other domestic purchasing, which would lead to lost jobs locally.

You should not believe the hype that New York City, as a center of international commerce, benefits from these agreements. In fact, we've lost massive numbers of jobs partly due to these bad deals. For example, in 2000, there were about 173,000 manufacturing workers in this city. Now there are 76,000.<sup>6</sup> (according to the most recent data available from the NYS DOL). While manufacturing job losses aren't exclusively the result of these deals, the current "free" trade model is a very substantial driver. The same is true of lost call center jobs – and job losses in many other sectors from back-office functions to medical technology. Free traders say that these job losses are dwarfed by the gains from trade, but those gains are hyped and do not compensate. To take one example, Rep. Greg Meeks often cites JFK jobs as a reason to be a free trade deal supporters. Yet employment at JFK actually has not increased over time. Certainly, there are some jobs created by these deals, but they are hugely outnumbered by job losses. The free-traders' arguments are simply a mirage.

Finally, as President Obama, Mayor de Blasio, and many Councilmembers have said, growing income inequality is the great challenge of our time. There is a broad academic consensus that our trade deals have fueled the growth of inequality.<sup>7</sup> For analysts and researchers, the question isn't *whether* trade deals have increased American income inequality, it's *how much* trade deals have increased income inequality. It's easy to see why: the main losers in these deals are middle and lower-income communities, including disproportionately communities of color. The main beneficiaries of the current regime are the corporate executive and investor class. The evidence suggests that somewhere between 10 and 40 percent of the growth of US inequality is a result of trade flows.

For these and other reasons, CWA and every other national labor union oppose Fast Track, which is the legislative process to ram the TPP through Congress. That unity of opposition is simply unprecedented. Our unified opposition reflects our practical experience trying to protect and create good American jobs. It also reflect the growing body of academic evidence that these so-called "free" trade deals are ruining America.

The world, led by the U.S., should move to a new model of trade that emphasizes raising standards, not fueling a global race to the bottom that enhances corporate profits and a global elite's wealth at everyone else's expense. Trade can generate real gains, but the TPP will not. It will devastate our communities if it is enacted. Thank you for giving us the opportunity to express our support for the Resolution.

We call upon you to co-sponsor Res 576, introduced by Helen Rosenthal, to "Make NYC a TPP Free Zone." We call upon you to ask council member Karen Koplowitz to bring the resolution out of committee and hold public hearings so that city residents can comment and consult.

The petition is being circulated by the International Trade Education Squad of the Park Slope Food Coop. At the General Meeting in September of 2014, coop members voted to form a work squad to keep our 16,400 members informed about Fast Track legislation and the TPP. We felt the need to assign member-labor to bring our community reliable information on this extremely impactful proposal. Negotiations are kept secret and the media has not thoroughly reported on the negotiations nor the the positions of members of congress. The Investor-State Dispute Settlement mechanism subjects rules and regulations promulgated by you and the NYC Council to being contested in a private tribunal that can award tax-payer money in penalties if corporate lawyers rule that investors' profits have been affected by laws that the members of the City Council enact. Such a court has no ground rules nor accountability.

We urge you to please co-sponsor Resolution 576. Prevail upon Council Member Koplowitz to bring Res 576 out of the committee and to hold public hearings so that comments offered in an open consultation can be considered.
