## Office of Administrative Trials and Hearings Overview

The Office of Administrative Trials and Hearings (OATH or the Department) is an independent, central court that consists of four tribunals: the OATH tribunal, the Environmental Control Board (ECB), the Taxi and Limousine (TLC) Tribunal and the Health Tribunal.

#### Fiscal 2017 Preliminary Plan Highlights

- **OATH Fiscal 2017 Budget.** The Preliminary Plan for OATH includes \$39.9 million in Fiscal 2016 for OATH. Personnel services funding comprises approximately 76.8 percent of its total Fiscal 2016 Budget for OATH and provides for 263 full-time positions.
- **Tribunal Fine Revenue**. It is projected that OATH will generate combined tribunal fine revenue of \$127 million in Fiscal 2017. ECB fine revenue represented 71 percent of the Office's total fine revenue in Fiscal 2015.
- **ECB Outstanding Debt**. The Department of Finance collects outstanding debt generated by ECB fines. The amount of this debt as of November 2015 was \$1.58 billion from 1.5 million outstanding notices of violation, up \$91 million from June 2014.
- **ECB Performance**. Compared to the same period year, the total number notices of violation received by the ECB increased by 4,712, while the number of ECB decisions rendered decreased by 1,366.
- **OATH Contract Budget.** OATH's Fiscal 2016 Contract Budget totals \$2.2 million for 20 contracts and accounts for 24.5 percent of the Department's total OTPS budget.

When compared to the Fiscal 2016 Adopted Budget, OATH's Budget increases by \$769,000 due to normal budget growth related to inflation and collective bargaining adjustments. In addition, OATH's total headcount increases by 10 positions, of which six will staff and operate the newly created Center for Creative Conflict Resolution. OATH's budget can absorb the personnel expenditures without a need for a budget increase. As such there is no new funding associated with the increase in headcount.

**Hearing Officer.** The November Plan for OATH included new baseline funding of \$135,400 for a hearing officer, bringing OATH's total number of hearing officers to 13. Hearing officers conduct hearings and write decisions in cases involving alleged violations of local laws and the rules and regulations of the City of New York or other laws or rules within OATH's ECB and Hearing Division Tribunal jurisdiction.

**Lease Savings.** Due to delays in moving into the 4th floor of the Falchi Building in Long Island City, OATH will incur \$482,000 in lease savings in Fiscal 2017.

#### **Tribunals**

The chart below outlines the Fiscal 2017 Preliminary Budgets of the four administrative tribunals.

#### **OATH Tribunal**

The Fiscal 2017 Preliminary Budget includes \$6.9 million for the OATH Tribunal, including \$4.2 million to support 47 full-time positions. The OATH Tribunal conducts disciplinary, disability, and adjudicatory hearings for City agencies. Hearings conducted by the OATH tribunal include: disciplinary cases brought by City agencies against civil service employees; matters pertaining to licensing, regulatory and enforcement authority, including cases involving City contractors; holders of various City licenses and loft tenants and their landlords; and hearings conducted after the New York City Police Department (NYPD) seizes vehicles of drivers accused of crimes.

#### **Health Tribunal**

The Fiscal 2017 Preliminary Budget includes \$6.1 million for the Health Tribunal, including \$5.5 million to support 52 full-time positions. The OATH Health Tribunal provides hearings for individuals and businesses charged with violating laws related to, or affecting health within New York City. The Health Tribunal does not issue Notices of Violation

(NOVs) and does not conduct inspections. The Tribunal schedules about 65,000 cases each year. Most of the cases involve public health and environmental sanitation, with the largest number of cases coming from inspections of food service establishments.

#### Taxi and Limousine Commission Tribunal

The Fiscal 2017 Preliminary Budget includes \$5 million for the TLC Tribunal, including \$3.6 million to support 27 full-time positions. The TLC Tribunal is responsible for holding hearings on tickets that are issued by the TLC, NYPD and the Port Authority of NY/NJ. These tickets are issued to TLC licensees and non-licensees for violations of NYC laws and TLC rules and regulations. The TLC Tribunal is not a part of the TLC. Tribunal judges do not work for the TLC and are independent, impartial decision-makers.

#### **Environmental Control Board (ECB)**

ECB is the City's largest tribunal, and holds 200,000 hearings annually on quality of life and public safety charges that are filed by 13 different agencies, including the Department of Buildings, the Fire Department, the Department of Environmental Protection and the Department of Sanitation. The Fiscal 2017 Preliminary Budget includes \$21.5 million for the ECB, including \$17 million to support 129 full-time positions.

#### **Tribunal Fine Revenues**

The Health Tribunal, TLC Tribunal, and the ECB generate revenue for the City through the collection of fines issued for various violations. Revenues totaled \$141.2 million in Fiscal 2015.

It is projected that OATH will generate combined tribunal fine revenue of \$126.8 million in Fiscal 2016. ECB fine revenue represented 71 percent of OATH's total fine revenue in Fiscal 2015. Revenue generated through Health Tribunal fines have decreased since peaking at \$53.6 million in Fiscal 2012. The decrease is due in large part to the Council's efforts to reform the City's restaurant grading system. In October 2013, the Council passed legislation that improved the oversight and performance of the restaurant inspection system. In March of 2014, the Council and the Department of Health and Mental Hygiene announced new restaurant grading rules designed to reduce fines and provide additional educational resources to help restaurants maintain high health standards throughout New York City.

## **Appendix B: Contract Charts**

The New York City Charter mandates the preparation of a Contract Budget to identify expenditures for contractual services, which are defined as any technical, consultant or personnel service provided to the City by means of a contract. The Contract Budget is actually a subset of the OTPS portion of the City's Expense Budget. The Administration prepares a Contract Budget twice each fiscal year. In January, it is prepared with the Departmental Estimates, and in late April it is submitted to the Council with the Executive Budget.

OATH's Fiscal 2017 Contract Budget totals \$2.2 million for 20 contracts and accounts for 24.5 percent of the agency's total OTPS budget. Security Services for the Tribunals represent 25.2 percent of the OATH's total contract budget.

When compared to the same time last fiscal year, the number of OATH ECB Hearings Division decisions rendered decreased by 1,366. This indicator is defined as the Total number of notices of violation (NOV) where a decision has been rendered by the ECB Tribunal. Possible decisions include dismissal, found in violation (respondent is found guilty and must pay the fine and/or correct), or stipulated (only available for certain

violations; represents an admission of guilt, accepting the stipulation to remedy the problem). This decrease is despite that fact that the total number NOVs received by the OATH ECB Hearings Division increased over the same period by 4,712.

Average time that an OATH ECB hearing was assigned to a judge to when that judge made decision a final decision decreased from six days to four days over the same period last fiscal year. The 2016 PMMR attributed this decrease to the continued improvement in ECB Division's efficiency and its provision of timely decisions in the cases it hears.
