3	My name is David Greenfield. I'm the Councilman from
4	the 44 th Councilmanic District in Brooklyn. I'm
5	privileged to serve as Chair of the Land Use
6	Committee. I want to welcome my esteemed colleagues
7	who are members of the committee here today. Council
8	Member Gentile, Council Member Dickens, Council
9	Member Garodnick, Council Member Mendez, Council
10	Member Rodriguez, Council Member Koo, Council Member
11	Levin, Council Member Williams, Council Member Wills,
12	Council Member Barron, Council Member Cohen, Council
13	Member Kallos, Council Member Torres, Council Member
14	Treyger and we are still updating the list. As
15	always, I want to thank Chair Dickens, Chair Richards
16	and Chair Koo for their work chairing their
17	respective subcommittees, and Council Member Reynoso.
18	We will be voting today to approve four applications.
19	These resolutions before you represent the
20	recommendations of the Subcommittees for presentation
21	of vote by the full Council. Please note that LU 422
22	and 423, the rezoning at Broadway and Sherman in
23	Council Member Rodriguez's district is being laid
24	over.

2	We're going to start first with LU 425,
3	Black Tree BK, application for a revocable consent to
4	establish, maintain and operate an unenclosed
5	sidewalk café at 261 Metropolitan Avenue located in
6	Council Member Reynoso's district. This application
7	has been withdrawn, and we're voting on a motion to
8	file LU 425 to remove it from our calendar.
9	Preconsidered LU 426 Ali Baba's Café,
10	application for revocable consent to establish,
11	maintain and operate an unenclosed sidewalk café
12	located at 862 Second Avenue. This application is in
13	Council Member Garodnick's district, and he has
14	supported after modifications to reduce the size of
15	the café.
16	We have three items on our agenda from
17	the Landmarks Subcommittee. The first two are
18	preconsidered items, 77 Greenwich Street School,
19	application pursuant to Section 1732 of the New York
20	City School Construction Authority Act concerning the
21	proposed site selection for new or approximately 476-
22	seat primary school facility located on the north
23	side of Edgar Street between Trinity Place and
24	Greenwich Street. The application is in Council

2 Member Chin's district, and she is supportive of the 3 application.

Draper Hall, Phase 2 application pursuant 4 5 to Section 7385(6) of the Health and Hospitals Corporation Enabling Act concerning the construction 6 7 of a 16-story apartment building including approximately 153 apartments for low-income 8 9 individuals or families of Draper Hall on the Metropolitan Hospital Campus Center located at 1918 10 11 First Avenue. The application is in the Speaker's District, and she is supportive of this application. 12

LU No. 418 Bell Ahles House proposed 13 14 designation by the Landmarks Preservation Commission 15 of John Williams and Lydia Ann Bell Ahles' house located 39-24 213<sup>th</sup> Street as an individual landmark. 16 17 This building is in Council Member Vallone's 18 district, and he is supportive of this designation 19 and as Chair Koo has pointed out, this is, in fact, a 20 direct result of the legislation that was sponsored by Chair Koo and myself that has taken this item off 21 the calendar and now we are seeing a multitude of 2.2 23 landmarks thanks to legislation of the Council Member. The Council is overwhelmingly supportive. 24
