Belmont Business Improvement District

The Wildlife Conservation Society/Bronx Zoo urges the New York City Council's Committee on Finance to pass legislation to create the Belmont Business Improvement District in the Bronx, NY.

The Bronx Zoo has supported the creation of the Belmont Business Improvement District (BID) since its inception and the Zoo realized early on that the economic health and success of the area known as "Little Italy" is vital to the community in which it sits. The Bronx Zoo has been a partner with the Belmont Small Business Association for 11 years. The partnership has been a symbiotic one and has brought tourism to both institutions. The economic health of this area and the stability of the neighborhoods that surround it are fundamentally intertwined.

The Belmont Small Business Association has taken a leadership role in safety issues, beautification of the area, the promotion of area events such as those at the Bronx Zoo, and the commitment to make the Belmont business district a strong economic anchor for tourism. The commitment to the growth of small businesses is evident with the legislation to create a business improvement district that sits before the New York City Council's Committee on Finance.

Business Improvement Districts are important to the City because they help retain and attract businesses to the District and promote healthy economic development for the City. The Belmont Small Business Association is dedicated to promoting business development and improving the area's quality of life. If approved, the Belmont BID will deliver supplemental services such as sanitation and maintenance, public safety and visitor services, marketing and promotional programs, capital improvements, and beautification for the area.

The Bronx is the home to many small businesses that have weathered the ups and downs of a changing economy. The small businesses of the Belmont area are diverse and some have been in the community for generations and others are new but all will benefit with the approval of the Belmont BID.

The Wildlife Conservation Society/Bronx Zoo supports the creation of the Belmont BID and we urge the New York City Council to pass legislation to create the Belmont BID.
