CHAIRPERSON FOSTER: Good

afternoon. I'm Council Member Helen Diane Foster, Chair of the Parks and Recreation Committee. This meeting is being held on Intros 608 and it has to do with the correct naming of a street so that EMS and other personnel can know where they're going. And in the process of doing some name changes, we didn't change it completely. I'm going to ask Council Member Addabbo to speak on it briefly. Oh, excuse me; it's 776, 815 and 500 in addition to 608. Council Member?

COUNCIL MEMBER ADDABBO: Madam

Chair, thank you very much. I also want to thank
my Committee Members, my Colleagues and also the

staff of this Committee for allowing us to
introduce this Intro today, actually two of them,
to address this situation, an issue of safety.

Down in the areas of Howard Beach there are
certain roads that are familiar in number as far
as address is concerned, but they're separated by
water. There's Shellbank Basin that separates two
parts of Howard Beach and the Conduit Avenue,
basically, separates two parts. And EMS
frequently has issues about where certain

2	locations or a certain emergency exists. And as				
3	we know, with emergencies, every second counts. I				
4	am hopeful with these two introductions and the				
5	name changes that we do, not only does it make it				
6	more clear for EMS and 911 but also in a true				
7	emergency it could save a life. Many of our				
8	residents have spoken out in favor of these and				
9	have brought it to my attention, and I				
10	wholeheartedly agree with them that we are				
11	correcting something that for decades has been an				
12	issue. Some of the name changes that we are doing				
13	in parts of Howard Beach were traditional names				
14	years ago. Over time, for some reason, these				
15	names have changed to numbers, and that has caused				
16	great confusion. So now we are correcting				
17	something that has been in existence for decades.				
18	And I appreciate your help, as Chair, and again				
19	your staff. Thank you very much.				
20	CHAIRPERSON FOSTER: Thank you.				
21	We've been joined and I'm sorry I didn't do this
