2 CHAIRPERSON LAPPIN: Are we ready
3 to go? We're re-opening the meeting of the Land
4 Use Subcommittee on Landmarks, Public Siting and
5 Maritime Uses. It's being continued from, when
6 was it last? October 16th. We're voting on just
7 one item that is in the Speaker's district that we
8 have laid over twice, the West Chelsea Historic
9 District, which is item number 884. I wanted to

16 issue resolved in terms of the small, little

19 COUNCIL MEMBER PALMA: Okay.

20 CHAIRPERSON LAPPIN: It is still
21 within the district that we will be voting on
22 today.

23 COUNCIL MEMBER PALMA: Okay. Thank
24 you.

25 CHAIRPERSON LAPPIN: And I would

2 like to ask Christian Hylton, the Counsel, to call
3 for a vote.

CHRISTIAN HYLTON: By a vote of five in the affirmative, none in the negative, no abstentions, the item is referred to the full Land Use Committee.

CHAIRPERSON LAPPIN: Council Member Oddo, would you like to vote on the previous items as well?

COUNCIL MEMBER ODDO: Yes, thank you. I vote yes.

CHRISTIAN HYLTON: By a vote of eight in the affirmative, none in the negative, no abstentions, all items are referred to the full Land Use Committee except LU 884, which is approved and referred to the full Land Use Committee with a vote of five in the affirmative, two in the negative, no abstentions.
