REPORT OF THE COMMITTEE ON FINANCE

RESOLUTION APPROVING THE NEW DESIGNATION AND CHANGES IN THE DESIGNATION OF CERTAIN ORGANIZATIONS TO RECEIVE FUNDING IN THE FISCAL 2010 EXPENSE BUDGET

The Committee on Finance, to which was referred the above-captioned resolution, respectfully submits to The Council of the City of New York the following

R E P O R T

Introduction. The Council of the City of New York (the "Council") annually adopts the City's budget covering expenditures other than for capital projects (the "expense budget") pursuant to Section 254 of the Charter. On June 19, 2009, the Council adopted the expense budget of fiscal year 2010 with various programs and initiatives (the "Fiscal 2010 Expense Budget").

Analysis. This Resolution, dated September 30, 2009 sets forth new program areas to be funded by the Department of Juvenile Justice ("Department"). The Fiscal 2010 Expense Budget included \$640,000 for the Discharge Planning: Collaborative Family Initiative. In the Fiscal 2010 Expense Budget, the Council designated the Research Foundation of the City University of New York as the program administrator for this initiative. Pursuant to the provisions in the Fiscal 2010 Expense Budget, the program administrator would designate the organizations to receive funding, and the amount each organization would receive, under this initiative. In a communication from the Department to the City Council Finance Division ("Division"), dated September 29, 2009, the Department informed the Division of its decision on organizations to be funded using the funding provided in the Fiscal 2010 Adopted Budget. In such communication, the Department selected the Coalition for Hispanic Family Services to be funded in the amount of \$425,000, and the Research and Evaluation Center of John Jay College, City University of New York to be funded in the amount of \$215,000. This Resolution approves such selection.

Also, this Resolution amends the description for the Description/Scope of Services for the Food Pantries Program within the budget of the Human Resources Administration. The Description/Scope of Services for such program listed in the Fiscal 2010 Expense Budget read: "This allocation represents funding to support food pantries citywide. To ensure that hungry New Yorkers have continued access to emergency food programs \$800,000 of the allocation is used for direct purchase of food, \$200,000 for technical assistance grants to assist in the automation of food stamp enrollment at food pantries, soup kitchens and other appropriate locations, and \$500,000 for capacity expansion efforts at Emergency Food Assistance Program (EFAP) food pantries." This Resolution now changes the Description/Scope of Services to read: "This allocation represents funding to support food pantries citywide. To ensure that hungry New Yorkers have continued access to emergency food programs \$800,000 of the allocation is used

for direct purchase of food, \$200,000 for technical assistance grants to assist in the automation of food stamp enrollment at food pantries, soup kitchens and other appropriate locations, and \$500,000 for capacity expansion efforts for the Emergency Food Assistance Program (EFAP) administered by Food Bank for New York City."

Lastly, this Resolution approves new designations and changes in the designation of certain organizations receiving local, aging, and youth discretionary funding in accordance with the Fiscal 2010 Expense Budget. This Resolution also approves the new designations and changes in the designation of certain organizations to receive funding pursuant to certain initiatives in the Fiscal 2010 Expense Budget.

In an effort to continue to make the budget process more transparent, the Council is providing a list setting forth new designation and/or changes in the designation of certain organizations receiving local, aging, and youth discretionary funding (or Council discretionary funding), as well as new designations and/or changes in the designation of certain organizations to receive funding pursuant to certain initiatives in the Fiscal 2010 Expense Budget.

This Resolution sets forth new designations and specific changes in the designation of certain organizations receiving local initiative funding, as described in Chart 1, attached hereto as Exhibit A; sets forth new designations and changes in aging discretionary funding, as described in Chart 2 attached thereto as Exhibit B; sets forth new designations and specific changes in the designation of certain organizations receiving youth discretionary funding, as described in Chart 3, attached thereto as Exhibit C; and sets forth the new designations and changes in the designation of certain organizations that will receive funding pursuant to certain initiatives in the Fiscal 2010 Expense Budget, as described in Charts 4-18, attached hereto as reflected in Exhibits D-R.

The charts, attached to the resolution, contain the following information: name of the council member(s) designating the organization to receive funding or name of the initiative, as set forth in Adjustments Summary/Schedule C/ Fiscal 2010 Expense Budget, dated June 19, 2009; name of the organization; organization's Employer Identification Number (EIN), if applicable; agency name; increase or decrease in funding; name of fiscal conduit, if applicable; and the EIN of the fiscal conduit, if applicable.

Specifically, Chart 1 sets forth the new designation and changes in the designation of certain organizations receiving local discretionary funding.

Chart 2 sets forth the new designation and changes in the designation of certain organizations receiving aging discretionary funding.

Chart 3 sets forth the new designation and changes in the designation of certain organizations receiving youth discretionary funding.

Chart 4 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Domestic Violence and Empowerment (DoVE) Initiative.

Chart 5 sets forth the new designation of certain organizations receiving funding in the amount of \$20,000, totaling \$5,100,000 in the aggregate, pursuant to the Cultural After School Adventure (CASA) Initiative.

Chart 6 sets forth the new designation of certain organizations receiving funding for the Immigrant Opportunities Initiative totaling, in the aggregate, \$5,000,000.

Chart 7 sets forth the new designation and changes in the designation of certain organizations receiving funding pursuant to the Healthy Aging Initiative.

Chart 8 sets forth the new designation and changes in the designation of a certain organization receiving funding pursuant to the Intergenerational Initiative. As indicated in Chart 8, The Metropolitan New York Coordinating Council on Jewish Poverty is acting as a fiscal conduit for the Senior Citizens League of Flatbush, Inc.

Chart 9 sets forth the new designation and changes in the designation of an organization receiving funding pursuant to the Information and Referral Contracts Initiative. Chart 9 indicates a name change. The Fiscal 2010 Expense Budget listed American-Italian Coalition of Organizations, Inc (AMICO) as the name for an organization receiving funding pursuant to this Initiative. The correct name for this organization is American-Italian Coalition of Organizations, Inc (AMICO)- Extended Services Program.

Chart 10 sets forth the new designation of organizations receiving funding in the amount of \$6,100.48, totaling 2,550,000.64 in the aggregate, pursuant to the Transportation Costs Initiative.

Chart 11 sets forth the new designation of organizations receiving funding in various amounts, totaling \$1,500,000 in the aggregate, pursuant to the Autism Initiative.

Chart 12 sets forth the new designation of organizations receiving funding in various amounts, totaling \$545,000 in the aggregate, pursuant to the Asthma Control Program Initiative.

Chart 13 sets forth the new designation of organizations receiving funding in various amounts, totaling \$2,500,000 in the aggregate, pursuant to the Obesity Prevention Initiative.

Chart 14 sets forth the new designation of organizations receiving funding in various amounts, totaling \$550,000 in the aggregate, pursuant to the Alcoholism/Substance Abuse Initiative.

Chart 15 sets forth the new designation of organizations receiving funding in various amounts, totaling \$1,500,000 in the aggregate, pursuant to the Injection Drug Users Health Alliance Initiative.

Chart 16 sets forth the new designation of Food Bank for New York City, to receive funding in the amount of \$500,000 pursuant to the Food Pantries Initiative.

Chart 17 sets forth an Initiative Fund Transfer for the Immigrant Opportunities Initiative (IOI) and the Cultural After School Adventure (CASA). As indicated in Chart 17, the funding for the IOI in the amount of \$235,800 within the budget of DYCD has been removed, and will be placed in the budget of CUNY to fund the IOI. Additionally, as indicated in Chart 17, the funding for CASA in the amount of \$200,000 within the budget of DCA has been removed, and will be placed in the budget of DYC D to fund the CASA initiative.

Chart 18* indicates a Fiscal 2009 Transfer of funds between organizations within the budget of DYCD. The sum of these changes are to reflect a clean up for FY 2009 in DYCD.

It is to be noted that organizations identified in the attached Charts with an asterisk (*) have not yet completed or began the prequalification process conducted by the Mayor's Office of Contract Services (for organizations to receive more than \$10,000) by the Council (for organizations to receive \$10,000 or less total), or other government agency. Organizations identified without an asterisk have completed the appropriate prequalification review.

Description of Above-captioned Resolution. In the above-captioned resolution, the Council would approve the new designation and changes in the designation of certain organizations to receive funding in the Fiscal 2010 Expense Budget. Such resolution would take effect as of the date of adoption.

To ensure that hungry New Yorkers have continued access to emergency food programs \$800,000 of the allocation is used for direct purchase of food, \$200,000 for technical assistance grants to assist in the automation of food stamp enrollment at food pantries, soup kitchens and other appropriate locations, and \$500,000 for capacity expansion efforts for the Emergency Food Assistance Program (EFAP) administered by Food Bank for New York City." and be it further
