Resolution affirming the designation by the Landmarks Preservation Commission of Public School 66 (P.S. 66Q) (The Jacqueline Kennedy Onassis School), located at 85-11 102<sup>nd</sup> Street (Tax Map Block 9183, Lot 1), Borough of Queens, Designation List No. 425, LP-2317 (L.U. No. 62; 20105351 HKQ (N 100221 HKQ).

WHEREAS, the Landmarks Preservation Commission filed with the Council on January 21, 2010 a copy of its designation dated January 12, 2010 (the "Designation"), of Public School 66 (P.S. 66Q), (formerly the Brooklyn Hills School, later the Oxford School, now The Jacqueline Kennedy Onassis School), located at 85-11 102<sup>nd</sup> Street (a.k.a. 85-01 to 85-19 102<sup>nd</sup> Street; 102-01 85<sup>th</sup> Road; 102-02 85<sup>th</sup> Avenue), Community District 9, Borough of Queens as a landmark, and Tax Map Block 9183, Lot 1, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on March 12, 2010 its report on the Designation dated March 10, 2010 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on April 7, 2010; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

RESOLVED:

Pursuant to Section 3020 of the City Charter, and on the basis of the information and materials contained in the Designation and the Report, the Council affirms the Designation.
