WHEREAS, the Landmarks Preservation Commission filed with the Council on April 27, 2012 a copy of its designation dated April 17, 2012 (the "Designation"), of the Barbizon Hotel for Women located at 140 East 63<sup>rd</sup> Street, aka 136-146 East 63<sup>rd</sup> Street, 813-817 Lexington Avenue, Community District 8, Borough of Manhattan, as a landmark and Tax Map Block 1397, Lots 1501-1588, as its landmark site pursuant to Section 3020 of the New York City Charter;
