## THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 1498

Resolution approving motion to file pursuant to withdrawal of application for an Urban Development Action Area Project located at 165 West 80<sup>th</sup> Street (Block 1211, Lot 7), Borough of Manhattan, and waiving the urban development action area designation requirement and the Uniform Land Use Review Procedure, pursuant to Sections 693 and 694 of the General Municipal Law (L.U. No. 627; 20125696 HAM).

## By Council Members Comrie and Levin

WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council on May 7, 2012 its request dated April 10, 2012 that the Council take the following actions regarding the following Urban Development Action Area Project (the "Project") located at 165 West 80 th Street (Block 1211, Lot 7), Community District 7, Borough of Manhattan (the "Disposition Area"):

- 1. Find that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the municipality and that the proposed Urban Development Action Area Project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law;
- 2. Waive the area designation requirement of Section 693 of the General Municipal Law pursuant to said Section;
- 3. Waive the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the General Municipal Law;

- 4. Approve the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law; and
- 5. Approve an exemption of the Project from real property taxes pursuant to Section 577 of Article XI of the Private Housing Finance Law (the "Tax Exemption").;

WHEREAS, by submission dated August 28, 2012 and submitted to the City Council on August 29, 2012, the Department of Housing Preservation and Development withdrew the application.

#### RESOLVED:

The Council approves the motion to file pursuant to withdrawal in accord with Rules 6.40a and 11.80 of the Rules of the Council.
