WHEREAS, the Department of Consumer Affairs filed with the Council on October 2, 2012 its approval dated October 2, 2012 of the petition of MCSR Restaurant Corp., d/b/a Bar 30 Lounge, for a revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 34-19 30<sup>th</sup> Avenue, Community District 1, Borough of Queens (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");

WHEREAS, the Petition is subject to review by the Council pursuant to Section 20-226(e) of the Administrative Code;

WHEREAS, by letter dated October 15, 2012, and submitted to the City Council on October 23, 2012, the applicant withdrew its application for the revocable consent.
