No. 968; 20145123 HKK; N 140116 HKK).

WHEREAS, the Landmarks Preservation Commission filed with the Council on September 27, 2013 a copy of its designation dated September 17, 2013 (the "Designation"), of the Long Island Business College, located at 143 South 8<sup>th</sup> Street (a/k/a 143-149 South 8<sup>th</sup> Street), Community District 1, Borough of Brooklyn as a landmark and Tax Map Block 2132, Lot 30, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on November 8, 2013, its report on the Designation dated November 4, 2013 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on November 21, 2013; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
