WHEREAS, the Landmarks Preservation Commission filed with the Council on November 8, 2013 a copy of its designation dated October 29, 2013 (the "Designation"), of the 339 Grand Street House, located at 339 Grand Street (aka 57 Ludlow Street), Community District 3, Borough of Manhattan as a landmark and Tax Map Block 309, Lot 19, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on December 30, 2013, its report on the Designation dated December 18, 2013 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on January 28, 2014; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;
