WHEREAS, the Department of Consumer Affairs filed with the Council on July 8, 2014 its approval dated July 7, 2014 of the petition of 50 W. 72<sup>nd</sup> Rest, LLC, d/b/a Riposo 72, for a revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 50 West 72<sup>nd</sup> Street, Community District 7, Borough of Manhattan (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");

WHEREAS, the Petition is subject to review by the Council pursuant to Section 20-226(g) of the Administrative Code;
