Be it enacted by the Council as follows:

Section 1. Subdivision a of section 20-672 of the administrative code of the city of New York is

amended by adding a new paragraph 4 to read as follows:

4. Where the price for purchases made with cash or other specified form of payment is less than the

price for purchases made with any other form of payment, such sign, poster, or placard shall state the price for

each type of accepted payment.

§ 2. This local law takes effect on the same date as a local law amending the administrative code of the

city of New York relating to price displays on signage in gas stations, as proposed in introduction number 287-

A for the year 2014, takes effect.
