WHEREAS, the Landmarks Preservation Commission filed with the Council on November 6, 2014 a copy of its designation dated October 28, 2014 (the "Designation"), of the First German Baptist Church (Later Ukranian Autocephalic Orthodox Church of St. Volodymyr/Later Congregation Tifereth Israel Town and Village Synagogue), located at 334 East 14<sup>th</sup> Street (a/k/a 334-336 East 14<sup>th</sup> Street), Community District 3, Borough of Manhattan as a landmark and Tax Map Block 455, Lot 24 in part, as its landmark site pursuant to Section 3020 of the New York City Charter;
