**Resolution affirming the designation by the Landmarks Preservation Commission of the Mills Hotel No. 3, located at 485 Seventh Avenue (a/k/a 481-489 Seventh Avenue, 155-163 West 36<sup>th</sup> Street) (Tax Map Block 812, Lot 1), Borough of Manhattan, Designation List No. 475, LP-2424 (L.U. No. 168; 20155203 HKM; N 150158 HKM).**

WHEREAS, the Landmarks Preservation Commission filed with the Council on November 6, 2014 a copy of its designation dated October 28, 2014 (the "Designation"), of the Mills Hotel No. 3, located at 485 Seventh Avenue (a/k/a 481-489 Seventh Avenue, 155-163 West 36<sup>th</sup> Street), Community District 5, Borough of Manhattan as a landmark and Tax Map Block 812, Lot 1, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on December 19, 2014, its report on the Designation dated December 17, 2014 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on January 13, 2015; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

RESOLVED:
