WHEREAS, the Department of Consumer Affairs filed with the Council on March 13, 2015 its approval dated March 10, 2015 of the petition of 002 Mercury Tacos, LLC, d/b/a Otto's Tacos, for a revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 131 7<sup>th</sup> Avenue South, Community District 2, Borough of Manhattan (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");
