WHEREAS, the New York City School Construction Authority submitted to the Council on August 4, 2015, a site plan pursuant to Section 1732 of the New York State Public Authorities Law for a new, approximately 450-Seat Primary School Facility, known as P.S. 398-Queens, to be located on the north side of 34<sup>th</sup> Avenue between 69<sup>th</sup> and 70<sup>th</sup> Streets (Block 1242, Lot 32), in the Jackson Heights section of Queens, Community District No. 3, Borough of Queens, serving students in pre-kindergarten through fifth grade in Community School District No. 30 (the "Site Plan");

WHEREAS, the Site Plan is subject to review and action by the Council pursuant to Section 1732 of the New York State Public Authorities Law;

WHEREAS, upon due notice, the Council held a public hearing on the Site Plan on August 11, 2015;

WHEREAS, the Council has considered the relevant environmental issues, including the negative declaration issued on August 3, 2015, (SEQR Project Number 16-004) (the "Negative Declaration"); and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the
