A Local Law to amend the New York city charter, in relation to the development of a disaster plan by the board of elections.

## Be it enacted by the Council as follows:

Section 1. Chapter 46 of the New York city charter is amended by adding a new section 1057-c to read

as follows:

§1057-c Disaster plan. The board of elections shall develop a plan for holding an election event

following a natural disaster or other state of emergency. Such plan shall:

a. be developed in coordination with the emergency management department;

b. include, but need not be limited to, plans for administering an election event as effectively as possible

## in cases of extreme weather, power outages, and acts of terrorism;

c. include information on who is responsible for necessary tasks in the event of such a disaster, what

financial and labor resources would be required to run an election event, which other agencies' assistance would be necessary to assist in running the election event or making it possible to run the election event, and what steps will or have been taken to limit the disruption of such a potential disaster on the board of elections' ability to hold an election event;

d. be completed by March 1, 2017 and updated periodically as necessary; and

e. be sent to the mayor and the speaker of the council.

§ 2. This local law shall take effect immediately.
