A Local Law to amend the administrative code of the city of New York, in relation to taxicab licenses.

Be it enacted by the Council as follows:

Section 1. Subdivision a of section 11-1402 of the administrative code of the city of New York is

amended to read as follows:

a. [On and after July first, nineteen hundred eighty] <u>On or after the effective date of the local law that</u> <u>amended this subdivision</u>, there is hereby imposed and there shall be paid a tax on each transfer of a taxicab license or interest therein, at the rate of [five percent] <u>0.5 percent</u> of the consideration given for such transfer.

§ 2. This local law takes effect immediately.
