A Local Law in relation to reducing apprenticeship program directive requirements

Be it enacted by the Council as follows:

Section 1. By March 1, 2019, the mayor's office of contract services, in consultation with any other relevant agencies or offices, shall reduce the threshold value for individual construction contracts and construction-related maintenance contracts covered by the apprenticeship program directive issued by the

mayor's office of contract services on May 21, 2015 to \$1,000,000, pursuant to approval by the New York State department of labor.

§ 2. This local law takes effect immediately.
