WHEREAS, the New York City Department of Consumer Affairs filed with the Council on May 17, 2018 its approval dated May 16, 2018 of the petition of Ephesus Corp., d/b/a, Seven Hills Mediterranean Grill, for a new revocable consent to maintain, operate and use an unenclosed sidewalk café located at 158 West 72<sup>nd</sup> Street, Community District 7, Borough of Manhattan (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");
