A Local Law to amend the New York City Charter, in relation to the composition of the Veterans' Advisory Board.

Be it enacted by the Council as follows:

Section 1. Subdivision d of Section 14 of the Charter of the city of New York is hereby amended to read as follows:

§ 14. Office of veterans' affairs.

* * *

- d. Veterans advisory board. There shall be a Veterans' advisory board consisting of [five] <u>nine</u> members , <u>all of whom shall be veterans</u>, [three] <u>five</u> of whom shall be appointed by the mayor and [two] <u>four</u> of whom shall be appointed by the speaker of the council of the city of New York. <u>Of these nine appointees</u>, there shall be one representative from each of the five boroughs of the city of New York. All members shall serve for a term of three (3) years. The board shall advise the director on all matters concerning veterans.
 - § 2. This local law shall become effective 60 days after its enactment.
