RESOLUTION NO. 105

Resolution approving an Urban Development Action Area Project located at 116 Manhattan Avenue, a.k.a. 141 Johnson Avenue (Block 3061/Lot 1), Brooklyn, and waiving the urban development action area designation requirement and the Uniform Land Use Review Procedure, pursuant to Sections 693 and 694 of the General Municipal Law (L.U. No. 13; 20045283 HAK).

WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council on October 29, 2003 its request dated October 8, 2003 that the Council take the following actions regarding an Urban Development Action Area Project (the "Project") located at 116 Manhattan Avenue, a.k.a. 141 Johnson Avenue (Block 3061/Lot 1), Community District 1, Borough of Brooklyn (the "Disposition Area"):

- 1. Find that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the municipality and that the proposed Urban Development Action Area Project is consistent with the policy and purposes of Section 691 of the General Municipal Law;
 - 2. Waive the area designation requirement of Section 693 of the General Municipal Law pursuant to said Section;
- 3. Waive the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the General Municipal Law; and
- 4. Approve the Project as an Urban Development Action Area Project pursuant to Section 694 of the General Municipal Law.

WHEREAS, the Project is to be developed on land that is now a municipally-owned area as defined in Section 692 of the General Municipal Law, consists solely of the rehabilitation or conservation of existing private or multiple dwellings or the construction of one to four unit dwellings, and does not require any change in land use permitted under the New York City Zoning

The Council waives the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the General Municipal Law.				
The Council approves the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law.				
The Project shall be disposed of and developed upon the terms and conditions in the Project Summary that HPD has submitted to the Council, a copy of which is attached hereto.
