THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 451

Resolution approving the decision of the City Planning Commission on ULURP No. C 030515 MMK, an amendment to the City Map (L.U. No. 150).

WHEREAS, the City Planning Commission filed with the Council on May 10, 2004, its decision dated May 10, 2004 (the "Decision"), on the application submitted by the Department of City Planning, pursuant to Sections 197-c and 199 of the New York City Charter and Section 5-430 *et seq.* of the New York City Administrative Code, for a change in the City Map involving:

- the elimination, discontinuance and closing of Red Hook Lane between Boerum Place and Fulton Street;
- the adjustment of grades necessitated thereby; and
- any acquisition or disposition of real property related thereto;

Community District 2, Borough of Brooklyn, in accordance with Map Nos. X-2665 and X-2666 dated November 20, 2003 and signed by the Borough President (ULURP No. C 030515 MMK) (the "Application");
