# THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 281

Resolution approving the decision of the City Planning Commission on an application submitted by the Department of Housing Preservation and Development, ULURP No. C 060177 HAK, approving the designation of 207 and 209 South Portland Avenue, 206 and 208, 214 and 216 South Oxford Street (Block 2004/Lots 1, 2, 78-82 and 84) p/o Site 3 within the Atlantic Terminal Urban Renewal Area, Brooklyn, as an Urban Development Action Area, approving the project for the area as an Urban Development Action Area Project, and approving the disposition of such property to a developer to be selected by the Department of Housing Preservation and Development (L.U. No. 65; C 060177 HAK).

#### By Council Members Katz and Garodnick

WHEREAS, the City Planning Commission filed with the Council on March 27, 2006 its decision dated March 22, 2006 (the "Decision"), on the application submitted by the Department of Housing Preservation and Development pursuant to Section 197-c of the New York City Charter and Article 16 of the General Municipal Law of New York State regarding:

- a) the designation of property located at 207 and 209 South Portland Avenue, 206 and 208, 214 and 216 South Oxford Street (Block 2004/Lots 1, 2, 78-82 and 84) p/o Site 3 within the Atlantic Terminal Urban Renewal Area, as an Urban Development Action Area (the "Area");
- b) an Urban Development Action Area Project for such area (the "Project"); and

pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer to be selected by the Department of Housing Preservation and Development to facilitate the development of a ten-story building, tentatively known as Atlantic Terrace, with approximately 80 residential units above ground floor retail, to be developed under HPD's Cornerstone Program (the "Disposition"), Community District 2, Borough of Brooklyn (ULURP No. C 060177 HAK) (the "Application");

WHEREAS, the Application is related to ULURP Application Number C 060176 ZMK (L.U. No. 64), an amendment to the Zoning Map, changing from a C6-1 District to a C6-2 District;

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(1) of the City Charter;

WHEREAS, the Application and Decision are subject to review and action by the Council pursuant to Article 16 of the General Municipal Law of New York State;

WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council its recommendations regarding the Application on April 12, 2006;

WHEREAS, upon due notice, the Council held a public hearing on the Application and Decision on April 10, 2006;

WHEREAS, the Council has considered the relevant environmental review (CEQR No. 05HPD018K) and the fact that a negative declaration was issued on November 1, 2005;

WHEREAS, the Council has considered the land use and financial implications and other policy issues relating to the Application;

#### RESOLVED:

The Council finds that the actions described herein will have no significant effect on the environment;

Pursuant to Section 197-d, the Council approves the decision of the City Planning Commission (C 060177 HAK).

The Council finds that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the City of New York and that a designation of the Project as an urban development action area project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law.

The Council approves the designation of the Disposition Area as an urban development action area pursuant to Section 693 of the General Municipal Law.

The Council approves the Project as an urban development action area project pursuant to Section 694 of the General Municipal Law.

The Council approves the disposition of said property to a developer to be selected by the Department of Housing Preservation and Development.
