THE COUNCIL OF THE CITY OF NEW YORK RESOLUTION NO. 317

Resolution approving with modifications the petition for a revocable consent for an unenclosed sidewalk café located at 2896 Broadway, Manhattan (20065196 TCM; L.U. No. 117).

WHEREAS, the Department of Consumer Affairs filed with the Council on March 24, 2006 its approval of the petition dated March 24, 2006 of Deluxe on Broadway, Inc., d/b/a Café Deluxe, for a revocable consent to continue to maintain and operate an unenclosed sidewalk café located at 2896 Broadway, Community District 9, Borough of Manhattan (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");

WHEREAS, the Petition is subject to review by the Council pursuant to Section 20-226(g) of the Administrative Code;

WHEREAS, upon due notice, the Council held a public hearing on the Petition on May 2, 2006; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Petition,

RESOLVED:

Pursuant to Section 20-226 of the Administrative Code, the Council approves the Petition with the following modifications:

- 1. The area of the sidewalk café shall extend no more than eight (8) feet, six (6) inches from the building;
- 2. The sidewalk café shall have eighteen (18) tables and thirty-six (36) chairs;
- 3. The configuration of the tables and chairs shall be nine (9) tables and eighteen (18) chairs either side of the restaurant double door entrance; and
- 4. The tables shall be no larger than twenty-one (21) inches in length and twenty-one (21) inches in width.
