A Local Law in relation to the naming of five thoroughfares and public places, Actors' Equity Corner, Borough of Manhattan, Josephine Diana Blvd., Borough of Brooklyn, Rev. Msgr. Bryan J. Karvelis Way, Borough of Brooklyn, Sgt. Jose Gomez Place, Borough of Queens and Dr. Reverend Wyatt Tee Walker Square, Borough of

Manhattan and the repeal of sections 3, 26 and 47 of local law number 13 for the year 2006.

Be it enacted by the Council as follows:

Section 1. Section 3 of local law number 13 for the year 2006 is hereby REPEALED.
