## Be it enacted by the Council as follows:

Section 1. Subdivision c of section two of local law number 37 for the year 2006 is amended to read as follows:

c. Such members of the task force shall serve until [February 17, 2007] <u>December 31, 2007</u>, after which

§2. This local law shall take effect immediately upon its enactment and shall be deemed to have been in full force and effect as of February 17, 2007.
