WHEREAS, the Landmarks Preservation Commission filed with the Council on December 1, 2006 a copy of its designation dated November 14, 2006 (the "Designation"), of the New York Cab Company Stable located at 318-330 Amsterdam Avenue, aka 201-205 West 75<sup>th</sup> Street, Community District 7, Borough of Manhattan, as a historic landmark and Block 1167/Lot 29, as its landmark site pursuant to Section 3020 of the New York City Charter:
