Resolution approving a motion to file pursuant to withdrawal respecting an Urban Development Action Area Project located at Block 3841/Lot 32, Block 3865/Lot 46, Block 3865/Lot 47, Block 3866/Lot 41, Block 3866/Lot 68, Block 4295/Lot 19, and Block 4295/Lot 72), Brooklyn, and waiving the urban development action area designation requirement and the Uniform Land Use Review Procedure, pursuant to Sections 693 and 694 of the General Municipal Law (L.U. No. 404; 20075312 HAK).

## By Council Members Katz and Garodnick

WHEREAS, the New York City Department of Housing Preservation and Development ("HPD") submitted to the Council on March 13, 2007 its request dated February 20, 2007 that the Council take the following actions regarding the following Urban Development Action Area Project (the "Project") located at Block 3841/Lot 32, Block 3865/Lot 46, Block 3865/Lot 47, Block 3866/Lot 41, Block 3866/Lot 68, Block 4295/Lot 19, and Block 4295/Lot 72), Community District 5, Borough of Brooklyn (the "Disposition Area"):

- 1. Find that the present status of the Disposition Area tends to impair or arrest the sound growth and development of the municipality and that the proposed Urban Development Action Area Project is consistent with the policy and purposes stated in Section 691 of the General Municipal Law;
- 2. Waive the area designation requirement of Section 693 of the General Municipal Law pursuant to said Section;

3. Waive the requirements of Sections 197-c and 197-d of the New York City Charter pursuant to Section 694 of the General Municipal Law;

4. Approve the Project as an Urban Development Action Area Project pursuant to Section 694 of the General Municipal Law; and

5. Approve the exemption of the Project from real property taxes pursuant to Section 696 of the General Municipal Law (the "Tax Exemption").

WHEREAS, by submission dated May 31, 2007, the Department of Housing Preservation and Development withdrew the application.

RESOLVED:

The Council approves the motion to file pursuant to withdrawal in accord with Rules 6.40a and 11.80 of the Rules of the Council and Section 2-02(d) of the New York City Rules and Regulations.
