WHEREAS, the Department of Consumer Affairs filed with the Council on August 9, 2007 its approval of the petition dated July 24, 2007 submitted by KMG Group, LLC, d/b/a Molly Pitcher's Ale House (the "Applicant"), for a revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 1641 Second Avenue, Community District 8, Borough of Manhattan, (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");
