WHEREAS, the Department of Consumer Affairs filed with the Council on August 22, 2007 its approval of the petition dated August 2, 2007 of 1650 Broadway Associates, Inc., d/b/a Stardust Diner (the "Applicant"), for a revocable consent to establish, maintain and operate an unenclosed sidewalk café located at 1650 Broadway, Community District 5, Borough of Manhattan, (the "Petition"), pursuant to Section 20-226 of the New York City Administrative Code (the "Administrative Code");
