No. 585; 20085037 HKM (N 080030 HKM).

WHEREAS, the Landmarks Preservation Commission filed with the Council on August 3, 2007, a copy of its designation dated July 24, 2007 (the "Designation"), of the Thomas Jefferson Play Center located on First Avenue between East 111<sup>th</sup> Street and East 114<sup>th</sup> Street, Community District 11, Borough of Manhattan, as a landmark and Block 1705, p/o Lot 1, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on September 7, 2007 its report on the Designation dated September 5, 2007 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on October 9, 2007; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

RESOLVED:

Pursuant to Section 3020 of the City Charter, and on the basis of the information and materials contained in the Designation and the Report, the Council affirms the Designation.
