Resolution affirming the designation by the Landmarks Preservation Commission of Manhattan House located at 200 East 66th Street (Block 1420, Lot 1), Manhattan, Designation List No. 397, LP-2246 (L.U. No. 656; 20085189 HKM (N 080170 HKM).

WHEREAS, the Landmarks Preservation Commission filed with the Council on November 9, 2007 a copy of its designation dated October 30, 2007 (the "Designation"), of Manhattan House, located at 200 East 66<sup>th</sup> Street (aka 200-260 East 66<sup>th</sup> Street, 201-257 East 65<sup>th</sup> Street, 1241-1259 Second Avenue, 1111-1129 Third Avenue), Community District 8, Borough of Manhattan, as a landmark and Block 1420, Lot 1, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on December 26, 2007 its report on the Designation dated December 19, 2007 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on January 22, 2008; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

**RESOLVED**:

Pursuant to Section 3020 of the City Charter, and on the basis of the information and materials contained in the Designation and the Report, the Council affirms the Designation.
