Whereas, On June 15, 2007, the Council of the City of New York (the “City Council”) adopted the Fiscal 2008 Expense Budget with various programs and initiatives (the “Adopted Fiscal 2008 Budget”); and

Whereas, The City Council is hereby implementing and furthering the appropriations set forth in the Adopted Fiscal 2008 Budget by approving or disclosing the new designation and changes in the designation of certain organizations to receive funding pursuant to certain initiatives, and by approving the new designation and changes in the designation of certain organizations receiving aging discretionary funding in accordance therewith; now, therefore, be it

Resolved, That changes in the designation of certain organizations receiving aging discretionary funding are reflected in Chart 1, attached hereto as Exhibit A; and be it further

Resolved, That the City Council hereby discloses the new designation and changes in the designation of certain organizations to receive funding pursuant to the Adult Literacy Services Initiative as set forth in Chart 2, attached hereto as Exhibit B; and be it further

Resolved, That the City Council hereby approves the new designation and changes in the designation of certain organizations to receive funding pursuant to the Cultural After School Adventure (CASA) Initiative, as set forth in Chart 3, attached hereto as Exhibit C; and be it further

Resolved, That the City Council hereby approves the designation of certain organizations to receive funding pursuant to the HIV/AIDS Outreach Enhancement Initiative as set forth in Chart 4, attached hereto as Exhibit D; and be it further

Resolved, That the City Council hereby approves the designation of certain organizations to receive funding pursuant to the Infant Mortality Reduction Initiative as set forth in Chart 5, attached hereto as Exhibit E; and be it further
