WHEREAS, the City Planning Commission filed with the Council on May 21, 2008 its decision dated May 21, 2008 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the New York City Department of Housing Preservation and Development for the acquisition of property located at 515, 519, and 521 St. Marks Avenue (Block 1149, Lots 63, 65, and p/o 68), Community District 8, Borough of Brooklyn (the "Site"), to facilitate a residential development (ULURP No. C 080287 PQK) (the "Application");

WHEREAS, the Application is related to ULURP Application Number C 080288 HAK (L.U. No. 771), an urban development action area project designation and project approval and the disposition of cityowned property;

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b) (2) and (3) of the City Charter;

WHEREAS, upon due notice, the Council held a public hearing on the Decision and Application on June 2, 2008;
