WHEREAS, the City Planning Commission filed with the Council on November 20, 2008 its decision dated November 19, 2008 (the "Decision") on the application submitted pursuant to Section 197-c of the New York City Charter by the Department of Housing Preservation and Development for property located at 148 West 143rd Street (Block 2011, Lot 57), Community District 10, Borough of Manhattan (the "Site"), (ULURP No. C 080502 PQM) (the "Application");

WHEREAS, the Application is related to ULURP Application Number C 080501 HAM (L.U. No. 887), a UDAAP designation and project approval, and disposition of city owned property;

WHEREAS, the Decision is subject to review and action by the Council pursuant to Section 197-d(b)(2) and (3) of the City Charter;

WHEREAS, upon due notice, the Council held a public hearing on the Decision and Application on December 15, 2008;

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Decision and Application;
