Resolution affirming the designation by the Landmarks Preservation Commission of the Public National Bank of New York Building, located at 106 Avenue C (Block 377, Lot 72), Borough of Manhattan, Designation List No. 405, LP-2263 (L.U. No. 950; 20095184 HKM (N 090114 HKM)).

WHEREAS, the Landmarks Preservation Commission filed with the Council on September 23, 2008 a copy of its designation dated September 16, 2008 (the "Designation"), of the Public National Bank of New York Building (later Public National Bank & Trust Company of New York Building), located at 106 Avenue C a/k/a 231 East 7th Street, Community District 3, Borough of Manhattan, as a landmark and Block 377, Lot 72, as its landmark site pursuant to Section 3020 of the New York City Charter;

WHEREAS, the Designation is subject to review by the Council pursuant to Section 3020 of the City Charter;

WHEREAS, the City Planning Commission submitted to the Council on November 20, 2008 its report on the Designation dated November 19, 2008 (the "Report");

WHEREAS, upon due notice, the Council held a public hearing on the Designation on December 15, 2008; and

WHEREAS, the Council has considered the land use implications and other policy issues relating to the Designation;

RESOLVED:

Pursuant to Section 3020 of the City Charter, and on the basis of the information and materials contained in the Designation and the Report, the Council affirms the Designation.
